<u>COMMISSION FOR ENERGY AND ENVIRONMENTAL SUSTAINABILITY "TIP OF THE</u> MONTH"

Commission for Energy and Environmental Sustainability Tip of the Month April 28, 2014 Read by Randy Bruce

The City of Farmington Hills will compete for the <u>Georgetown University Energy Prize</u>, a national competition that challenges communities across the U.S. to rethink their energy use. At a press conference in Washington, D.C. on April 23, Farmington Hills was announced as one of more than 50 communities competing for the prize.

The Georgetown University Energy Prize is open to U.S. communities with a population between 5,000 and 250,000. Farmington Hills will work closely with the City of Farmington, Farmington Public Schools, Consumers Energy, DTE Energy, and local experts to develop an energy efficiency/sustainability plan before June 30, 2014. The competition will conclude in 2017, when one winning community is awarded a \$5 million prize for use on energy efficiency programs.

The Commission for Energy and Environmental Sustainability will be working diligently over the next two months with Community Stakeholders to begin the application process and start framing the City's energy savings plan. Watch for more information on how you can participate.

Mayor Pro Tem Bruce thanked Assistant to the City Manager Nate Geinzer for all of the hard work he has put into the Georgetown University Energy Prize.

Mr. Geinzer stated that he and two other delegates went to Washington D.C. for the Georgetown University Energy Prize Launch Event as one of the original communities that submitted a letter of interest. While at the event they received tips and special training and Farmington Hills and Farmington were featured as part of the panel discussion at the press conference. Mr. Geinzer feels that Farmington Hills has a good start as far as a profile in this competition and he looks forward to competing hard in this challenge.

PRESENTATION OF WATER TOWER AWARD FROM MICHIGAN CONCRETE ASSOCIATION

Ms. Carrie Sutton, Michigan Concrete Association, presented an Award of Achievement recognizing the City of Farmington Hills Water Tower Project. She explained that this project competed against at least a dozen unique concrete projects across the state, and the judges felt that this was an amazing project that was well coordinated with many people working together to make it successful. Ms. Sutton also noted that along with the City the concrete contractor Landmark Structures, the supplier Superior Materials, the engineer OHM and Oakland County Water Resources were also recognized for partnering on this unique project.

Director of Public Services Mekjian thanked the Michigan Concrete Association for recognizing the Water Tower as "The Structural Project of the Year". Mr. Mekjian also thanked Mayor Brickner, City Council and City Manager Brock for their leadership and continued support.

Carol Posby, Co-chairperson of the Beautification Commission, presented the following 2013 Annual Report:

- Maintained membership and is active in the Beautification Council of Southeastern Michigan and the statewide Keep Michigan Beautiful Organization.
- 2013 Earth Day celebration is a highlight is the 2013 accomplishments because the commission felt 1 day was not long enough to recognize the importance of fostering environmental stewardship in the community so they developed a week long calendar of environmentally focused events including:
 - Water Conservation Day with Oakland County Water Commissioner, Jim Nash
 - Free showing of The Lorax at the Civic Theatre
 - The Litter Walk Clean-up
 - The Clean-up and planting of 150 White Pine saplings by students at Hillside Elementary
- Annual Flower Planting Project in the Costick Center Courtyard was held in June
- Two plant swaps were held at the Heritage Park Nature Center in May and September
- 28th Annual Beautification Ceremony was held on October 24th at the Costick Center

Beautification Commission 2014 Goals

- Annual Litter Walk Clean-up Event was held this past Saturday
- Tree City USA Certification and Arbor Day Tree Planting was also held last week in conjunction with the City's Earth Day Celebration
- Spring Plant Swap is scheduled for May 17th at Heritage Park
- Annual Costick Center planting will be held in June
- Fall Plant Swap is scheduled for September 13th
- Annual Awards Ceremony will be on October 23rd

In 2013 there were 2 new subcommittees formed:

- The Beautification Commission has joined with the Committee for Energy and Environmental Sustainability to explore opportunities to initiate and participate in projects that include identifying and preserving wild life corridors. The Commission will also be promoting public awareness regarding water quality and stream bank stabilization issues and identifying opportunities for expansion of riparian buffers.
- They are investigating the development and roll-out of an Adopt-A-Road initiative similar to the current Oakland County program.

PUBLIC QUESTIONS AND COMMENTS

Mr. Bastuba, Folsom Road, stated that he received a letter from the Library asking for donations because they are low on funds. He commented that all penal fines from the court should be going to the Library.

Councilmember Lerner explained that the letter came from The Friends of the Library, which is a 501(c)3 (non-profit) organization that raises money for the Library.

City Attorney Joppich responded that it is his understanding that not all fines, but a portion of certain types of fines go to the Library.

Mr. Bastuba asked for the law that states homes can be taken from people who do not pay their taxes.

City Attorney Joppich stated that there are statutes in place that address these issues and that provide very detailed procedures in the event that an individual property owner has a problem paying their taxes.

PUBLIC HEARING

<u>PUBLIC HEARING AND CONSIDERATION OF APPROVAL OF THE COMMUNITY</u> <u>DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM PROJECTED USE OF FUNDS FOR</u> <u>2014/2015, AND THE FIVE YEAR CONSOLIDATED PLAN CMR4-14-45</u>

Charmaine Kettler-Schmult from the Community Development Department stated that the issue before Council is for consideration of approval of the Community Development Block Grant funds, the annual use of the funds and the five-year consolidated plan. She noted that the public hearing is a Federal requirement in order to receive the funds, which must benefit low and moderate income persons as defined by the Department of Housing and Urban Development. She noted that this year's funding has been reduced by 8% and the City has received \$327,885. It is anticipated that the City will receive an additional \$35,000 in program income in repayment of deferred loans and carryover from this year is approximately \$27,610. The total budget is anticipated to be \$379,495. Ms. Kettler-Schmult explained that there has been a modification to the breakdown of the funds due to the new partnership with Oakland County in the form of the Home Consortium. Olde Town Park has been targeted for the Capital Improvement Project this year, which is located in the southeast quadrant of the City. She stated that the park was originally developed in 1976 and is in need of an update including fencing and handicapped accessibility. In addition, within the administration category HAVEN and Common Ground have both requested funding.

Councilmember Bridges stated that he is happy that the City is considering putting some resources into Olde Town Park. He inquired how the Administration costs are defined.

Ms. Kettler-Schmult stated that Administration costs cover staff and benefits and the City's contributions for Fair Housing. She stated that in the past, it has also included funding for any non-profit organizations such as HAVEN and Common Ground; and a small amount is allocated for supplies.

Mayor Brickner opened the Public Hearing.

Connie Monahan from HAVEN thanked the Mayor and City Council for past support, which has allowed them to serve 190 people in 2012/13 from Farmington Hills and 159 so far in the 2013/14 year. She mentioned that the Farmington Hills High Risk Response Team won an award from Oakland County this year and that team is co-run by HAVEN. Ms. Monahan thanked the Council again for their support and asked for their continued support this year.

Mayor Brickner closed the Public Hearing as there was nobody else wishing to speak.

MOTION by Lerner, support by Massey, that the City Council of Farmington Hills hereby approves the Community Development Block Grant Program budget to include: 1)\$135,000 for housing rehabilitation, 2)\$152,195 for capital improvements, and 3)\$92,300 for program administration to include \$5,000 to Haven and \$2,000 to Common Ground; and approves the capital improvement portion of the budget for park improvements to include accessibility improvements at Olde Town Park (Independence and Waldron) \$152,195; and approves the Five-Year Consolidated Plan; and authorizes the City Manager to prepare and submit an application for Community Development Block Grant funds to the U.S. Department of Housing and Urban Development by May 16, 2014.

Planning and Community Development Director Gardiner explained that the proposed zoning ordinance amendment provides for zoning regulations for seasonal outdoor sales such as Christmas Tree Sales, Pumpkin Sales and Fireworks. He stated that this ordinance was introduced by City Council at their last meeting and no changes were proposed at that time. If City Council approves the enactment of the Ordinance, it would become effective in 21 days.
