- 3. APPROVAL OF AGENDA: Cox made a **motion** to accept as written, 2nd by Scott; approved 5-0
- 4. APPROVAL OF MINUTES OF JUNE 8: Approval was tabled until next meeting.
- 5. APPROVAL OF SPECIAL MEETING JUNE 17: Cox made a motion to approve the minutes as written; seconded by Scott; approved 6-0 (Baxtresser arrived prior to this vote) James Hulett was welcomed as an official new member.
- 6. Unfinished Business
 - A. Museum Accession/De-Accession Reviews
 - 1. Golden submitted a wooden cask/barrel which was donated by Lee Cox from his parent's home.
 - 2. He also exhibited a commercial grade/hardware store type scale from the Howard farm at 12 Mile Rd. and Halsted.
 - 3. Stewart made a **motion** to accept both items, Scott seconded, motion approved 6-0.

- 4. Plantings would ideally be done this October or until ground freezes and will require "daily watering."
- 5. Discussed hooking up outside faucets.
- 6. Golden will contact Ellen Schnackel regarding moving forward on this.
- C. Membership
 - 1. Willyard acknowledged receipt of Stewart's resignation letter and stated she would be missed.
 - 2. He also pronounced a need for a recording secretary. This was discussed; Earl Baxtresser offered to fill in as Secretary Pro Tem.

- E. Stollberg Memorial
 - Baxtresser reported about the ordering of the memorial bench. Due to the confusion with Landscaping Forms, Inc., he paid for the order through his personal company and will need to be re-imbursed by the city.
 - 2. Stewart asked about the artist's rendering. Scott stated he is waiting for delivery. Baxtresser restated that he has a source to create the laser etching.
 - 3. Stewart commented on the delay in finalizing the memorial project and said she would like the commission to plan a publicized dedication ceremony of which she would like to take part.

 - 1. Golden commented on his wife's book (Joni Hubred-Golden). It is self-published and based on the stories of ten outstanding Farmington women.
 - 2. Stewart said she would forward her resources on the Earl Graser House to anyone who
