# **APPROVAL OF AGENDA:**

### **NEW BUSINESS:**

- 1. Certificate of Appropriateness 22-5, HD#313 Fractional School House
  - Restoration plans of building reviewed including 2 ramps added, ADA bath, vending window.
  - 2nd means of egress may be required by building code.
  - Ramps and decks must be freestanding from building
  - Secretary of Interior standards 2 & 9 cited

## **OLD BUSINESS:**

- 1. Certificate of Appropriateness 22-4, HD#15 Botsford Inn
  - Review of shutters and railing shop drawings and responses from manufacturer. All answers from shop drawing review were answered satisfactorily with materials changed to douglas fir and stainless fasteners.
  - Chimney mortar used in repair must be compatible with old brick.
  - Secretary of Interior standards 2 & 6 cited

Motion carried unanimously.

- 2. Certificate of Appropriateness 22-2, HD#508 Spicer House
  - Brava rubber product vs wood is the primary decision, asphalt is not an appropriate choice. Long term cost is similar and city has poor record with maintenance of this structure. Annual maintenance cost of a cedar roof will continue to rise over time.
  - Motion is for a synthetic (Brava) roof with copper valley, and retention and rehab of gutters/downspouts.
  - Conditions are alternative simulated clay tile ridge cap if feasible and final color selection TBD
  - Secretary of Interior standards 2, 6, and 9 cited

Motion by Thomson, supported by Klemmer.

Motion carried unanimously.
