#### PROCLAMATION RECOGNIZING OCTOBER 6-12, 2019 AS FIRE PREVENTION WEEK

The following Proclamation was read by Councilmember Bruce and accepted by Fire Fighter Stan Barnes:

## PROCLAMATION Fire Prevention Week October 6 – 12, 2019

"Not Every Hero Wears a Cape. Plan and Practice Your Escape."

WHEREAS, the Farmington Hills Fire Department is committed to ensuring the safety and

security of all those living in and visiting our City; and

**WHEREAS**, fire is a serious public safety concern both locally and nationally with four out of

five U.S. fire deaths occurring at home each year; and

**WHEREAS**, over 2,700 people died in home fires throughout the U.S. during 2018, according

to the National Fire Protection Association, with Fire Departments responding to

more than 387,000 home fires; and

**WHEREAS**, Fire Departments throughout the country responded to nearly 1.3 million fires in

2018 and home fires in Michigan that same year killed 139 residents in 107 residential fatal fires according to the Michigan Fire Inspectors Society; and

**WHEREAS**, today's home fires grow in size faster than ever, typically allowing as little as one

to two minutes to escape from the time the smoke alarm sounds, due to home furnishings burning faster and producing more toxic gases and smoke; and

**WHEREAS**, working smoke alarms cut the risk of dying in reported home fires in half, and

residents who have planned and practiced an escape plan identifying two exits and closing bedroom doors are more prepared and more likely to survive a fire:

and

WHEREAS, Farmington Hills Firefighter/Paramedics and Department members who serve on

the state's Community Risk Reduction Task Force are dedicated to reducing the

occurrence of home fires and home fire deaths and injuries through fire

prevention education, and the Farmington Hills Fire Department installed 672 smoke alarms, 92 carbon monoxide alarms, and one bed shaker for the hearing

impaired this year; and

WHEREAS, the Farmington Hills Fire Department joins with the National Fire Protection

Association in promoting the Fire Prevention Week 2019 theme, "Not Every

Hero Wears a Cape. Plan and Practice Your Escape."

**NOW, THEREFORE, BE IT RESOLVED** that I, Ken Massey, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby proclaim October 6 - 12, 2019 as **Fire Prevention Week** in the City of Farmington Hills, and urge all citizens to protect their homes and families and to support the efforts of the City's fire and emergency services.
