PROCLAMATION OPPOSING TRANSITIONING TO A CASHLESS SOCIETY

The following Proclamation was read by Councilmember Massey:

PROCLAMATION Mayor and City Council Oppose Transitioning to a Cashless Society August 24, 2020

WHEREAS, the rise of cashless establishments is giving way to discussions about a future

cashless society where the acceptance of cash for payment of goods and services

will no longer be allowed; and

WHEREAS, the Farmington Hills Mayor and City Council agree that this trend is a bad idea

that should be opposed by those in positions of public influence; and

WHEREAS, since all transactions would be made electronically, a cashless society raises

many concerns including decreased personal privacy, increased security risks, and the possibility of technical failures due to natural disasters or organizational

errors that could incapacitate the national economy; and

WHEREAS, inequities would arise for some low-income communities, people of color,

undocumented immigrants, and the homeless as they could be shut out of a cashless society due to a lack of financial stability, official identity documents, a bank account, internet access, a credit card or even a home address, all of which

facilitate participation in electronic payment systems; and

WHEREAS, a cashless society would create an additional burden on small businesses as they

would be forced to pay additional fees to credit card companies in order to

participate in exclusively cashless transactions; and

WHEREAS, the rise of a cashless society is being fueled by fears that handling cash could

spread the coronavirus, but medical experts confirm that cash is safe to use as

long as people adhere to hand-washing protocols; and

WHEREAS, despite current public health concerns, the Mayor and City Council feel that the

risks of identity theft, profiling, privacy invasion, and disenfranchising sectors of

society such as the poor, elderly or people of color present too great an

exclusionary barrier for this country to transition to a cashless society now or at

any time in the future.

NOW, THEREFORE, BE IT RESOLVED that I, Vicki Barnett, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby proclaim **opposition to the proposed transition to a cashless society** and encourage our community to exercise their options for convenience, anonymity, freedom, and equality, which remain inherent in a society that provides the option to conduct financial transactions with cash.

PROCLAMATION RECOGNIZING SEPTEMBER 2020 AS NATIONAL RECOVERY MONTH

The following Proclamation was read by Councilmember Newlin:

PROCLAMATION National Recovery Month September 2020

WHEREAS, according to the Substance Abuse and Mental Health Services Administration, in

2018, approximately 20.3 million people in the United States age 12 or older had

a substance use disorder; and

WHEREAS, currently, an estimated 1.7 million people suffer from opioid use disorders

related to prescription opioid pain relievers and 652,000 people suffer from

heroin use disorders, which are not mutually exclusive; and

WHEREAS, the Centers for Disease Control reported that more than 67,000 Americans died

in 2018 from drug overdoses, with synthetic opioids currently being the main

driver of drug overdose deaths; and

WHEREAS, substance use disorders occur when the recurrent use of alcohol and/or drugs

causes clinically or functionally significant impairment, such as health problems, disability, and failure to meet major responsibilities at work, school or home; and

WHEREAS, stigma and stereotypes often keep people from seeking treatment that could

improve their quality of life; and

WHEREAS, substance use disorder recovery efforts benefit both individuals and their

communities by focusing on the person's ability to live, work, learn, and fully

contribute to society.

NOW, THEREFORE, BE IT RESOLVED that I, Vicki Barnett, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby proclaim September 2020 as **National Recovery Month** in the City of Farmington Hills and call upon our citizens, public and private institutions, businesses, and schools to increase their awareness and understanding of substance use and the need for appropriate and accessible services to promote recovery.

<u>PROCLAMATION RECOGNIZING SEPTEMBER 2020 AS SUICIDE PREVENTION AWARENESS MONTH</u>

The following Proclamation was read by Councilmember Massey:

PROCLAMATION Suicide Prevention Awareness Month September 2020

WHEREAS, according to the CDC's National Center for Health Statistics, there were more

than 48,000 recorded suicides in the United States in 2018, and the annual U.S.

suicide rate increased 24% between 1999 and 2014; and

WHEREAS, suicidal thoughts can affect anyone regardless of age, gender, race, orientation,

income level, religion or background; and

WHEREAS, suicide is the second leading cause of death for people ages 10 to 34, the fourth

leading cause among people ages 35 to 54, and the eighth leading cause among

people ages 55 to 64; and

WHEREAS, we can reduce these disturbing numbers through public awareness, education,

and treatment, which are all crucial in preventing this tragic problem that causes loss of life, and terrible suffering for the families and loved ones who are left

behind; and

WHEREAS, Farmington SAFE (Suicide Awareness For Everyone) is dedicated to making a

difference by empowering community members, bringing the stigmatized topics of depression and suicide out into the open, and connecting those who need

mental health assistance to the many resources that are available.

NOW, THEREFORE, BE IT RESOLVED that I, Vicki Barnett, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby proclaim September 2020 as **Suicide Prevention Awareness Month** in the City of Farmington Hills and encourage community members to "Talk About

It" in order to raise awareness of depression and suicide and work together to prevent this tragic loss, which greatly impacts families and communities.

PROCLAMATION RECOGNIZING AUGUST 23-29, 2020 AS EMERGENCY MEDICAL SERVICES WEEK

The following Proclamation was read by Councilmember Boleware:

PROCLAMATION Emergency Medical Services Week August 23 – 29, 2020

WHEREAS, we honor all the heroic men and women who are part of the Emergency Medical

Services (EMS) team at the City of Farmington Hills and express our gratitude

for the critical role they play in our community's health and safety; and

WHEREAS, these dedicated professionals answer the call and provide urgent assistance 24

hours a day, seven days a week, responding immediately to any crisis, delivering life-saving care, and showing limitless compassion as they strive to improve the survival and recovery rate of all those who experience an emergency situation

firefighter/paramedics, firefighter/emergency medical technicians, dispatchers,

and police officers; and

WHEREAS. during this unprecedented time, the coronavirus has increased the demands on

EMS providers, and they have risen to the challenge, delivering critical care and

assistance to all those suffering from the effects of this pandemic.

CONSIDERATION OF APPROVAL OF THE RELOCATION OF PRECINCT 26 TO THE TAWHEED CENTER LOCATED AT 29707 W. 10 MILE ROAD.

City Clerk Smith explained that the Farmington Community School was closing so there was a need to move that voting precinct to a new location. Options were discussed by the Election Commission and the recommendation was to move the precinct location to the Tawheed Center on 10 Mile Road. She added that all affected residents would be notified by mail of the change and that both locations would be posted with permission from the facilities.

Discussion was held on absent voter ballots, mail service and city hall drop boxes that are available for voters to return their ballot.
