SUBJECT: Authorization for Grant Application to the U.S. Department of Transportation Reconnecting Communities and Neighborhoods (RCN) Program.

ADMINISTRATIVE SUMMARY

- The U.S. Department of Transportation (USDOT) has released notice of funding for the RCN Program.
- This program supports improving access to daily destinations such as jobs, education, healthcare, food and recreation to communities impacted by highways or transportation facilities that create barriers to community connectivity.
- This M-5 corridor has created a barrier to the community and the City intends to investigate solutions to improve connectivity, safety and mobility that can foster economic development, accessibility and improve quality of life for residents and visitors.
- Funding will be utilized to complete a Planning and Environmental Linkage study along the M-5 corridor. This will involve community involvement, data collection and analysis, assessing the effectiveness of possible alternatives and ultimately identifying potential improvements to pursue along the corridor.
- Federal funds are potentially available to offset up to eighty percent (80%) of the direct costs to complete the Planning and Environmental Linkage Study along M-5. The cost breakdown is approximately \$1,600,000 in Federal funds/\$400,000 in local matching funds.
- The Michigan Department of Transportation (MDOT) has indicated that they will support the application for funding. This is necessary as MDOT has jurisdiction over the M-5 corridor.
- The U.S. Department of Transportation requires that City Council submit a resolution of support with each grant application.

RECOMMENDATION

IT IS RESOLVED that the Farmington Hills City Council herby approve the attached resolution supporting the application to the U.S. Department of Transportation Reconnecting Communities and Neighborhoods Grant Program.

SUPPORT DOCUMENTATION

On September 12, 2022, City council adopted a resolution establishing a moratorium on the 5 on-premises liquor licenses available for a period of 90 days.

On December 12, 2022, City Council adopted an amendment to the previous resolution establishing a moratorium on three (3) of the five (5) on-premises liquor licenses available for an additional period of 270 days.

At a study session meeting held on April 24, 2023, City Council came to the following consensus regarding future applicants for the quota licenses and the moratorium in place:

Excerpt from minutes (full copy attached):

The consensus of Council was to bring the one application for a quota liquor license that was submitted and through the review process first to the next City Council meeting of May 8, 2023; receive more information from staff on the redevelopment and CIA licenses and master plan process and consider lifting the moratorium earlier than fall.

It was noted that if the last available quota license is issued at the May 8th meeting, the Clerk will notify the other two applicants but mention that Council is considering lifting the moratorium earlier than anticipated and once that is done, their applications may be submitted to City Council for consideration.

As the moratorium was not previously lifted, it will expire as of September 12, 2023 unless City Council chooses to extend the moratorium for all or a few of the 3 remaining on-premises liquor licenses.

A resolution is attached for your consideration should you determine to extend the moratorium. City Council would need to determine the number of days for which it would like to extend the moratorium and whether or not the moratorium will apply to all three (3) remaining on-premises liquor licenses.

Should City Council determine that they do not wish to extend the moratorium for any of the remaining on-premises liquor licenses, no action is needed. The moratorium will automatically expire and the two pending applications will be brought before City Council at a future meeting for consideration if the applicants still wish to move forward.

The study session meeting of the Farmington Hills City Council was called to order by Mayor Barnett at 5:35pm

PRESENTATION ON 2024 WATER AND SEWER RATES

Karen Mondora, Director of Public Services, stated that before City Council are the 2023/24 water and sewer rate recommendations. She introduced Raphael Chirolla, Drew Sandahl and Amy Ploof from WRC who were present to discuss the proposed rates.

Mr. Chirolla reviewed the basic rate calculation used to determine the rates. He reviewed the projected sewer and water sales for the city's system and noted that for FY 2024 they are estimating an average quarterly increase of \$22.93 in sewer rates and an average quarterly increase of \$14.86 in water rates per the average residential customer.

Director Mondora reviewed the major capital expenses for the water and sewer systems planned over the next 5 years.

Council inquired about minimum billing for those residents who are on a well and currently receive a flat rate water bill rather than a bill based on usage.

Director Mondora stated that staff discussed this issue and included in the resolution that will be coming to City Council in June for consideration will be the option for those residents to purchase a water meter so that their bill could be based upon usage rather than a flat rate. The cost for the water meter and for installation will be the responsibility of the homeowner. She cautioned that while it could reduce the costs for some residents, others may be surprised by their actual usage.

It was noted that there were 717 such properties in the city and discussion was held on potential assistant programs that residents may qualify for to assist them with their water bill or potentially the purchase and installation of the meter.

In response to Council, Mr. Chirolla stated that the proposed rates are for Farmington Hills only and do not include any costs or subsidies for other communities.

Discussion was held on potential state or federal funding to assist with infrastructure upgrades. Director Mondora explained the Farmington-Evergreen sanitary sewer system and how that works and explained that the city and or county is seeking funding where available.

Council inquired about the effectiveness of the Middlebelt Tunnel. Mr. Chirolla indicated that the Middlebelt Tunnel project is working effectively to reduce sanitary sewer overflows for which it was designed.

Council suggested educating the 717 customers on wells about their options for purchasing the meter. Director Mondora suggested that a letter could be included with the next bill.

DISCUSSION ON SHORT TERM RENTALS IN FARMINGTON HILLS

City Manager Mekjian stated that this issue was discussed with City Council at a previous study session and staff was asked to report back to Council on options for addressing the issues with illegal short term rentals of property.

Charmaine Kettler-Schmult, Director of Planning and Community Development discussed the tools being used to address these issues. She noted that short-term rentals are not a permitted use currently in residential areas and are only permitted in hotels or motels. Council will see a suggested amendment to the ordinance and definition of hotels/motels as another tool for the city to utilize as enforcement. She stated that some residents are not only renting out their homes, but pools, basketball hoops, parking areas, etc.

Information had been distributed to Council regarding the issues experienced over the past year and an example letter of how the city has addressed the concerns. She stated that in discussing this matter with the City Attorney's Office and 47th District Court, staff is suggesting that residents who receive a ticket for these violations will have to appear in person in court and will not be able to simply pay a fine. The issue was that a simple fine has not been enough to deter continued violations by residents.

City Attorney Joppich further clarified that municipal civil infractions can allow for injunctive relief and that is how the city and 47th District Court is proposing to handle future violations of this nature.

Director Kettler-Schmult and City Attorney Joppich explained the procedures that would be followed once a ticket was issued that included the courts flagging the ticket for a formal hearing and the city requesting injunctive relief. If found guilty by the court, the Judge would issue an order as such and if further violation continued the person could be found in contempt of court, which would be determined by a Judge in District Court. There is potential for jail time or if they failed to show at a hearing, a bench warrant may be issued.

Council inquired if the Police Department upon being called for a disturbance or other violation could shut down a party. Attorney Joppich responded that each call would continue to be handled on a case-by-case basis and it may not be shut down or even known that evening if violations for short term rentals are occurring but may be handled later through code enforcement.

City Manager Mekjian explained the need for more communication between departments for residences with known complaints and issues.

Council inquired if cars could be towed from Heritage Park if they are parked there after hours and if so, is there a sign to that effect. Staff confirmed there was a sign for no parking in Heritage Park after the park closes; however, they would check into the exact language and review strengthening that if needed to allow for towing of vehicles.

Director Kettler-Schmult pointed out that Council also received a proposed amendment to the ordinance for the definition of hotels/motels to provide staff another tool in dealing with these issues and this is where this type of short-term rental is currently permitted. There is also the option of reviewing no parking signs on public streets in certain locations, but that is typically requested by the neighborhood.

Discussion was held on short-term rentals that included overnight or weekly rentals versus monthly or longer that would fall under the city's home rental inspection program.

Council requested staff to look into Meridian as there have been many complaints on social media from Novi residents that this Farmington Hills business has been causing a lot of noise for their area.

Council also expressed concern with the increase in issues at the area hotels and motels and the challenge to keep up with those incidents.

It was mentioned that the city would be addressing any issues on a complaint basis or addressing concerns already known by the city and that it has not been past practice for the city to investigate or search for these rentals in order to issue violations.

DISCUSSION ON LIQUOR LICENSE POLICY/PROCESS

City Clerk Smith explained that the city currently has one quota liquor license available and 3 quota licenses still under a moratorium. Recently, City Council amended their liquor license policy to view applications as they were received and further clarification is needed as the Clerk's Office has received three applications, two of which have completed the review process and are ready to come before Council for consideration and another that is in the process but could be ready before the next meeting as well. Clerk Smith stated that she is seeking direction on whether Council wants all applications through the review process to come before them at the same meeting or if they want one at a time as the applications were submitted and completed the review process.

Considerable discussion was held on whether the Council should lift the moratorium on the other 3 quota licenses, the master plan process and potential for redevelopment licenses or development licenses through a Corridor Improvement Authority (CIA) district.

Attorney Joppich cautioned that the process of establishing additional CIA districts involves other entities and their approval.

The majority of Council agreed that the moratorium on the 3 quota licenses should be lifted earlier than fall to allow other applicants to pursue the licenses. Some members of council requested more information on the potential for redevelopment and CIA licenses prior to lifting the moratorium and the opportunity to vet the businesses requesting a license because once that license is issued, it essentially belongs to that business owner and could be placed in escrow or sold to be used outside of the city. Once issued, it is very difficult for the city to get the license back.

Clerk Smith indicated that as applications are brought to Council some of that information being requested such as investment in the community and financial stability will be provided or could be answered by the applicant at that time.

The consensus of Council was to bring the one application for a quota liquor license that was submitted and through the review process first to the next City Council meeting of May 8, 2023; receive more information from staff on the redevelopment and CIA licenses and master plan process and consider lifting the moratorium earlier than fall.

It was noted that if the last available quota license is issued at the May 8th meeting, the Clerk will notify the other two applicants but mention that Council is considering lifting the moratorium earlier than anticipated and once that is done, their applications may be submitted to City Council for consideration.

SUBJECT: Thirteen Mile Road Water Main Payback District (Valley Road to Wellington Drive), Section 12

Administrative Summary

- On August 22, 2022, City Council approved the Thirteen Mile Road Water Main Payback District, subject to final costs being established upon completion of construction.
- The public water main is now in service and final costs have been determined.
- City staff has determined that fourteen (14) properties benefit from the public water main and are being included in the payback district. This includes six (6) existing properties with frontage on Thirteen Mile Road and eight (8) new homes within the Hills of Franklin development.
- The total payback cost of the water main extension is \$600,002.00 or \$42,857.29 per unit. The cost per unit is below the original estimated amount of \$46,154.00 per unit.
- Each benefiting property is responsible for a proportionate share of this cost as based on the number of equivalent residential units that are projected to connect from each property. Each additional connection resulting from future lot splits will have to pay its proportionate share of the full cost attributable to the original benefitted property, as required by City Ordinance.
- A payback agreement stipulates that the owners of the benefiting parcels are only required to pay for their proportionate share of the improvement costs *if and when* they connect to the water main and also *prior to* the approval of any subdivision of land or lot split as outlined in City Code Section 27.
- In accordance with the payback ordinance, the developer of the eight (8) benefiting properties within the Hills of Franklin development will be obligated to pay this payback amount prior to the issuance of water connection permits for each of the homesites within the development.
- Should a benefiting parcel opt to pay for its proportionate share of the improvement costs within five (5) calendar years of the approval of the final establishment of the payback district, but not including any subdivision of land or lot split, its costs may be amortized over ten (10) years, with interest, through the City. This will be administered by the City Attorney and Finance Department.
- Staff recommends the approval of the Thirteen Mile Road Water Main Payback District Resolution and establishing the payback district and final payback amount.

RECOMMENDATION

IT IS RECOMMENDED, that City Council adopt the attached Resolution establishing the Thirteen Mile Road Water Main Payback District (Valley Road to Wellington Drive) and the final payback costs.

Support Documentation:

On August 22, 2022, the City Council gave approval for the Thirteen Mile Road Payback District, subject to final costs being determined upon completion of construction. On July 25, 2022, City Council awarded a construction contract for the Thirteen Mile Road Water Main Extension Project. This project included installation of new public water main along Thirteen Mile Road from Valley Drive to the southwest corner

of Thirteen Mile Road and Inkster Road, to support the Hills of Franklin development. This water main installation was an obligation per the existing Consent Judgment on this property.

Construction of the water main extension project is now complete, and staff has determined the final project cost to be \$807,678.94. It should be noted that the payback portion for this water main was capped by the referenced Consent Judgment with the condition that the developer pay for all costs above the capped amount. For this project the final payback district cost is \$600,002.00 (capped amount) and the Hills of Franklin developer separate from the payback is therefore responsible for \$207,676.94 for the water main construction.

There are fourteen (14) benefiting properties along the route of the new water main installation. Each benefiting property is responsible for a proportionate share of this cost as based on the total number of equivalent residential units that are projected to connect from each property. In the event that any of the properties split or develop differently than originally estimated, units of benefit will be recalculated such that each connection resulting from the lot splits or development will have to pay its proportionate share of the full cost attributable to the original benefited property, as required by City Ordinance. The City Assessor will follow up on the process of the paybacks prior to the approval of any subdivision of land or lot split as outlined in City Code Section 27.

Should a benefiting parcel opt to pay for its proportionate share of the improvement costs within five (5) calendar years of the approval of the final establishment of the payback districts, but not including any subdivision of land or lot split, its costs may be amortized over ten (10) years, with interest, through the City. Please note that the five-year time period for property owners to enter into an installment payment agreement with the City will be administered by the City Attorney and Finance Department.

Once the payback district costs are established, the City will record the resolution documents so that potential purchasers are aware of the payback amounts. City staff will notify property owners within the payback districts of the process for connection to the water main, options for payback installment payments, and the procedure for private property service line connections.

BE IT FURTHER RESOLVED that, pursuant to the Payback Ordinances, each of the above-described Benefitted Properties are not entitled and shall not be permitted to connect to the City's public water main until such time as the Payback Amount established for such property has been paid to the City or as directed by the City.

BE IT FURTHER RESOLVED, that any of the Benefitted Properties that are subdivided or split into more units than identified above, then the Payback Amount listed above for such property shall be paid in accordance with the requirements of City Code Section 33-201(b), as presently written or as said Code Section may be amended from time to time in the future or as such Code Section may be rewritten in another section of the Code in the future; and

BE IT FURTHER RESOLVED, except as to Parcels 22-23-12-228-001 through 22-23-12-228-008, which must pay the Payback Amount in full at the time of connection or within two-years of completion of the Water Main Extension, whatever is first, if a benefitted property connects to the Water Main Extension within five (5) years of the date of adoption of this resolution and that property is not being subdivided or split, then such property shall have the option to pay its Payback Amount in installments that coincide with the quarterly water service billings (or other water service billing interval that may be established by the City) over a period of up to ten (10) years after the date of such connection with per annum interest to be charged at the rate of 10-year Treasury Bonds plus one (1%) percent, but such installment payment option is subject to and contingent on the benefited property owner executing an installment pay back agreement prepared by the City Attorney and recording of such agreement with the Oakland County Register of Deeds against the benefited property.

BE IT FURTHER RESOLVED, that if a property does not connect to the Water Main Extension within five (5) calendar years of the adoption of this resolution, that property must pay its Payback Amount in one lump sum at the time of connection thereafter.

SUBJECT: Consideration of Award of Contract for the Kimberley Subdivision Water Main Replacement Project

Administrative Summary

- This project includes the construction of replacement water main in the Kimberley Subdivision as identified on the attached map.
- The project was publicly bid and advertised on the Michigan Inter-Governmental Trade Network (MITN) with bids opened on August 28, 2023.
- The lowest bidder who has demonstrated the ability to complete the work is Bidigare Contractors Inc. of Plymouth Township, Michigan. Their bid was in the amount of \$5,395,162.00. This bid amount is below the Engineer's estimate and within budget. Funds are available in the City's Water Fund.
- Bidigare Contractors Inc. has successfully completed several projects in the area, including a project in the City of Farmington Hills in 2019.
- Project information will be mailed to residents prior to the start of construction. A project open house meeting will also be held at City Hall prior to construction to display the plans and answer resident questions.
- The contractor will be allowed to start construction after award and the signing of the contract. It is anticipated that construction will begin in the fall 2023, dependent on material and supply issues. Substantial completion is anticipated within nine months of the project start date.

RECOMMENDATION

IT IS RESOLVED, the Kimberley Subdivision Water Main Replacement Project be awarded to the lowest competent bidder, Bidigare Contractors Inc. of Plymouth Township, Michigan, in the amount of \$5,395,162.00, and

IT IS FURTHER RESOLVED, the City Manager and the City Clerk be authorized to execute the contract on behalf of the City.

Support Documentation

The City of Farmington Hills has budgeted for the construction of replacement water main within the Kimberley Subdivision as shown on the attached map. The project was identified in the City's Capital Improvement Program. Funding is available from the City's water fund and the bid is within the budgeted amount. The project will include the installation of a high-density polyethylene pipe (HDPE) or similar pipe by using mostly a directional drill construction technique, thereby minimizing construction impact to the area.

On August 28, 2023, six (6) bids were received for the above referenced project (see Bid Summary). The low bid, provided by Bidigare Contractors Inc. is competitive with current prices in today's market. Bidigare Contracting has successfully completed similar projects for local municipalities in the Metropolitan Detroit area, including Rochester Hills, St. Clair Shores and Grosse Point. In addition, the contractor successfully completed a watermain job in the City of Farmington Hills in 2019. The Engineering Division has completed reference checks and indicates that their work was satisfactory. It is our opinion they can adequately perform the work as outlined in the contract.

SUBJECT: AWARD OF PURCHASE ORDER FOR UAVS FOR THE POLICE DEPARTMENT

ADMINISTRATIVE SUMMARY

- The Farmington Hills Police Department purchased the current drones over 5 years ago. The drones are experiencing numerous mechanical, electrical failures, and power source issues due to being at the end of their service life.
- Sealed bids were solicited by the City of Grand Rapids, posted on the MITN e-procurement system, opened and read aloud on July 26, 2023, for Drones and Accessories. The awarded contract with UVT (Unmanned Vehicle Technologies) is offered to the City of Farmington Hills as a cooperative bid. Participating in a cooperative purchase provides cost savings for the City due to the buying power of a cooperative.
- Drones are technology driven and as a result, become obsolete relatively quickly. Additionally, the current drones require substantial assembly before and disassembly after each flight. This slows the operator's ability to rapidly deploy the drone and contributes to mechanical failures. These technological, operational, and mechanical failures inhibit the ability to rapidly deploy this resource when searching for missing or wanted people. Drone technology continues to evolve, and this requested replacement equipment will address the current equipment challenges and improve the department's emergency response and investigative capabilities.
- The items included in the pricing:
 - 3 DJI Matrice 30T combos \$9,637.00 each
 - 10 DJI Matrice Flight Batteries \$329.00 each
 - 3 LP12 Speaker and Spotlight attachments \$2,095.00 each
 - 1 DJI Mavic 3 Enterprise \$3,788.00 each
 - 1 DJI Mavic 3 Enterprise Series Battery Kit \$659.00 each.
- The price also includes ProLine Support for Technical and Operations, ProLine Pre-Flight Service to ensure activation and hardware for all products, and 1 day training on all equipment.
- Funding for the drone is budgeted and available from the Police Department Capital Improvement Fund.

RECOMMENDATION

In view of the above, it is recommended that City Council authorize the City Manager issue a purchase order for the budgeted equipment for the Farmington Hills Police Department to UVT in the amount of \$40,786.35.

SUBJECT: PURCHASE OF JOHN DEERE TRACTOR FOR FARMINGTON HILLS GOLF CLUB DRIVING RANGE OPERATION

ADMINISTRATIVE SUMMARY

- The current driving range tractor with cage and cab is 14 years old with over 5600 engine hours and is utilized to pick-up the driving range golf balls. In the summer of 2022, the engine failed but our mechanic was able to rebuild it and get it running again. Last week the tractor had catastrophic failure. It is beyond its useful life. Currently, the range balls can only be picked with a regular golf cart and the range must be closed when this is occurring as there is no safety protection cage.
- The 18-hole golf course and driving range are a major source of revenue for the Special Services Department. The range has 34 stalls and dispenses over 3,500,000 range balls each year.
- Sealed proposals were advertised, publicly opened and read aloud by the State of Michigan (MiDeal) for Agricultural, Grounds & Maintenance Equipment. The awarded contract with Deere & Company is offered to the City of Farmington Hills as a cooperative bid. Participating in a cooperative purchase provides cost savings for the City due to the buying power of a cooperative.
- The John Deere 2038R Tractor with Driving Range Cage/Cab will be utilized to pick-up the driving range golf balls. It is designed to handle slopes, hills, and rough terrain while protecting the operator. In conjunction with the driving range picker the tractor will be used for various golf course projects.
- The equipment will be stored at Parks and Golf Maintenance Building.
- A two-year warranty for all parts & labor was required as part of the specifications.
- Funding for the John Deere 2038R Tractor and Cage is budgeted and available in the Special Services Parks Millage Fund.

RECOMMENDATION

In view of the above, it is recommended that City Council authorize the City Manager to approve a purchase order in the amount of \$37,404.40, including one (1) John Deere 2038R tractor for \$31,004.40 and one (1) John Deere Ball Cage for 2038R Cab for \$6,400.00, to John Deere and to take delivery of the equipment via Revels Turf & Tractor as an authorized dealer.

SUBJECT: PURCHASE OF CAR PRINTERS FOR POLICE DEPARTMENT

ADMINISTRATIVE SUMMARY

- The City of Farmington Hills Police contract with the Oakland County Courts Law Enforcement Management Information Systems (CLEMIS) for criminal justice and public safety applications. By serving as a technical link among multiple agencies, CLEMIS promotes communication and sharing of criminal justice information. The key principle of CLEMIS is securely sharing data between law enforcement agencies in a County-operated and maintained regional database.
- The Police Department is beginning the process of increasing its vehicle fleet for patrol purposes. The Police Department recently purchased 6 additional patrol vehicles. Each of these additional vehicles require an in car printer that is attached to the MDC (Mobile Data Computer). The department currently utilizes Brothers Rugged Jet thermal printer. In addition, these printers are compatible with the MDC and CLEMIS. The pricing for the computers is based on the Oakland County CLEMIS contract with CDW.
- The printers come with the following items: wireless router, antenna, USB cable, car adapter, mounting/power station, and a 3-year warranty.
- Each complete system will cost \$2,485.95. The total cost for 6 complete systems will be \$14,915.70.
- Funding for this purchase would are provided under the 2023-2024 Public Safety Milage.

RECOMMENDATION

Based on the above information, it is recommended that City Council authorize the City Manager to issue a purchase order to CDW in the amount of approximately \$14,914.50.

MINUTES CITY OF FARMINGTON HILLS FARMINGTON HILLS CITY COUNCIL CITY HALL - COMMUNITY ROOM AUGUST 28, 2023 – 5:30PM

The study session meeting of the Farmington Hills City Council was called to order by Mayor Barnett at 5:40pm

DISCUSSION OF THE HAWK INNOVATION CENTER AND STRUCTURE OF MANAGEMENT

Cristia Brockway, Director of Economic Development, stated that this evening's study session is focused on the business incubator located at The Hawk. She provided City council with a historical summary of the City's and EDC's efforts to date in creating, and ultimately attracting, the City's first participant in the incubator program. She noted that City Administration is requesting input and direction from members of City Council on the operation and management of the Incubator.

Director Brockway introduced members of the Economic Development Corporation (EDC) present at the meeting, including T.R. Carr, Chair; Susan Arlen, Chamber of Commerce; Mark Bruckey, Lawrence Tech.

T.R. Carr, Chair of the Economic Development Corporation, explained that discussion on a Hatchery has been discussed for some time and he provided a brief history of the Hatchery and how that evolved to date, including the creation of a 501c3 non-profit organization.

Mayor Barnett expressed concern that City Council never approved of the creation of this 501c3 organization that was established to manage the Hatchery. She stated that while it was discussed as one of the options, Council never approved the creation of the 501c3 but yet it seems to be moving forward in that direction and there will also be expenditures by the organization that will need to be approved.

EDC Chair Carr discussed the process for creating the 501c3 and indicated there have been no 501c3 expenditures by the City to date. He noted that offers of support for the Hatchery have come in without any advertising and he discussed the strengths of the Hatchery with Council.

Considerable discussion was held on the creation of the 501c3 and members of the Economic Development Corporation felt that in the past presentations that were made to Council, this was discussed as an option and also part of reports presented and there was also much discussion at the EDC meetings over the past several years.

EDC Member Arlen commented that synergy with the Hatchery was critical to potentially receiving MEDC grant funding.

Chair Carr added that members were present here tonight to update Council on the current status of the Hatchery and proposed next steps, which he reviewed with City Council.

Mayor Barnett reiterated her concerns with how the 501c3 was established, its current members and the appearance of having EDC members on the Board of Directors (BOD) and wanted more information on how the Board was formed, how vacancies will be filled, how it will be operated and who has oversight over the BOD.

Steve Joppich, City Attorney, explained that the city had an agreement with a company for use of the space even though the 501c3 organization was not yet in place, and that agreement established Cristia Brockway, the city's Economic Development Director, as the incubator temporary manager and a future incubator manager would be a non-profit organization or private corporation and the company was agreeing to that provision. He added that whatever direction is provided by City Council, that will be incorporated into the agreement.

Chair Carr outlined the format for the BOD of being 7-11 members with currently himself, Mark Bruckey and Lew Cantor being the 3 members as required to establish the 501c3.

Considerable discussion was held on the creation of the 501c3 organization and its formation.

Several members of Council assumed they would be proceeding with the 501c3 as outlined while others were unaware the 501c3 had been formed and wanted more information and an opportunity for City Council to weigh in on the discussion.

Jerry Ellis, Attorney for the Hatchery, added that a 501c3 organization can take up to a year to establish and that was one of the reasons they moved quickly to do so; but were shocked when they received approval within a month or two time.

Members of the Economic Development Corporation believed that the option for the 501c3 was discussed for months and was part of reports to council and discussed at many of their meetings over the past several years and therefore, thought the process was very transparent and that everyone was on the same page.

The consensus was for the proposed participation and use agreement to come back to City Council at a study session meeting on September 18, 2023 and to include the standard operating procedures, rules and procedures and information on the organization of the board of directors.

It was also the consensus in response to City Manager Mekjian, to move forward with the HAWK Hatchery with the additional information requested.

PUBLIC HEARING

PUBLIC HEARING AND CONSIDERATION OF AMENDMENT TO PLANNED UNIT DEVELOPMENT PLAN 5, 1993 DATED MAY 13, 2023 LOCATED AT 36455 AND 36555 CORPORATE DRIVE.

Erik Perdonik, City Planner, reviewed the proposed amendment that would allow for a new wall and monuments signage at the future site of Comerica Bank. He noted that typically signage would come before the Zoning Board of Appeals, but since signage was covered as part of the original PUD agreement, approval of an amendment by City Council is required. He noted that the Planning Commission held a public hearing on July 20th at which time they recommended approval to City Council following the public hearing this evening.

Chris Kojaian, owner of the building and landlord, provided a background the proposed development noting that they are connecting two existing buildings and they do not need the existing signage and are asking to clean up the PUD agreement in order to have appropriate signage for the new building that will also serve as a great recruitment tool for the business.

Mayor Barnett opened the public hearing.

Pam Gerald, resident, spoke in favor of the proposed amendment as proper signage is important to success of businesses.

There being no further comments, Mayor Barnett closed the public hearing.

MOTION by Bridges, support by Knol, that the City Council of Farmington Hills hereby approves the application for approval of an amendment to PUD Plan 5, 1993, dated May 13, 2023, and

IT IS FURTHER RESOLVED, that the City Council directs the City Attorney to prepare the appropriate PUD agreement stipulating the final PUD approval conditions and authorizing the identified zoning deviations for City Council consideration and final approval.

Mayor Barnett inquired about illumination of the proposed signage. Mr. Kojaian assured Council that the lighting would not adversely affect property across the freeway and that they would comply with the city's lighting ordinance.

City Planner Perdonik confirmed that if the amendment were approved this evening, a sign permit would be required and illumination standards reviewed at that time.

PUBLIC HEARING AND CONSIDERATION OF THE INTRODUCTION OF AN ORDINANCE AMENDING THE FARMINGTON HILLS CODE OF ORDINANCES, CHAPTER 34, "ZONING," ARTICLE 2, "DEFINITIONS," IN ORDER TO ADD A DEFINITION OF "SHIPPING CONTAINER" AND AMEND THE DEFINITION OF "BUILDING," AND TO AMEND ARTICLE 5, "SITE STANDARDS," SECTION 34-5.1, "ACCESSORY BUILDINGS AND STRUCTURES," TO INCLUDE A NEW SUBSECTION 34-5.1.1.H ADDRESSING VEHICLES, COMMERCIAL VEHICLES, RECREATIONAL EQUIPMENT, TRAILERS, STORAGE PODS, AND SHIPPING CONTAINERS AND SIMILAR OFF-SITE-BUILT ENCLOSURES THAT ARE USED AS AN ACCESSORY BUILDING OR USE (ZONING TEXT AMENDMENT 2, 2023).

Mayor Barnett explained that there was a minor publishing error in the public hearing notice for this evening so the public hearing will be opened for those in attendance and action postponed until the meeting of September 18, 2023. The public hearing will remain open for that meeting as well as closed following all comments from the public.

Charmaine Kettler-Schmult, Director of Planning and Community Development, explained that the proposed zoning text amendment outlines how shipping containers and similar items may be used within the city and where they are permitted to be located. The Planning Commission has unanimously recommended approval following their public hearing meeting. Director Kettler-Schmult stated that it is staff's recommendation that the public hearing is opened and postponed for further comments as well as discussion and determination by City Council until the meeting of September 18, 2023.

Mayor Barnett opened the public hearing. There being no comments at this time, Mayor Barnett suspended the public hearing until the regular City Council meeting of September 18, 2023.

MOTION by Bridges, support by Massey, that the City Council of Farmington Hills hereby postpones discussion and action on draft Zoning Text Amendment 2, 2023 until September 18, 2023.

PUBLIC HEARING AND CONSIDERATION OF THE INTRODUCTION OF AN ORDINANCE AMENDING THE FARMINGTON HILLS CODE OF ORDINANCES, CHAPTER 34, "ZONING," ARTICLE 2.0, SECTION 2.2, "DEFINITIONS," TO AMEND THE DEFINITION OF "MOTEL" (ZONING TEXT AMENDMENT 3, 2023).

Director Kettler-Schmult noted that the same error was made on this public hearing notices and staff is again recommending that the public hearing is opened and that further comments, discussion and determination by City Council are postponed until the meeting of September 18, 2023. She explained that the proposed zoning text amendment would provide for a definition of "motel" in order to address short term rentals and where those may be operated. The Planning Commission recommended approval to City Council following their public hearing meeting.

Mayor Barnett opened the public hearing.

Pam Gerald inquired about renting of motels for an extended period of time and the concern of human trafficking.

Mayor Barnett clarified that the ordinance is proposed to address air BnB's and short term rentals in residential neighborhoods.

Steve Joppich, City Attorney, explained that if a motel were to start operating and charging persons on a monthly basis, it would be considered a multi-family use and would be subject to those requirements.

There being no further comments, Mayor Barnett suspended the public hearing until the regular City Council meeting of September 18, 2023.

MOTION by Bridges, support by Knol, that the City Council of Farmington Hills hereby postpones discussion and action on draft Zoning Text Amendment 3, 2023 until September 18, 2023.
