3. APPROVAL OF AGENDA:

MOTION by Baxtresser, support by Scott, to approve the agenda as published. Motion carried 5-0.

4. APPROVAL OF MINUTES- November 8, 2017:

MOTION by Willyard, support by Hulett, to accept the minutes of November 8, 2017 as written. Motion carried 5-0.

5. UNFINISHED BUSINESS:

- A. Museum Accession/De-Accession Reviews: None
- B. Museum Improvement-
 - 1. Interior- Preliminary thoughts about constructing a stairway to the basement, underneath the existing second floor stairway, were discussed. Baxtresser mentioned the preliminary quotes for this were delayed.
 - 2. Work for the removal of the brick chimney in the Heritage Center will be addressed in the spring.
 - 3. Exterior- Work on the landscaping was discussed. Drawings provided by Betty Poole would be used for the primary concept. This work would commence in the spring.
 - 4. Scott inquired about the possibility of utilizing some space in the adjacent building for storage and display of the Historical Commission's horse drawn buggies.
- C. Brick Walk Brick Sales- The brick pavers that were set up for engraving have been

engraved and will await better weather for installation. Baxtresser presented an invoice from Ashcraft Landscape Design and Construction for \$45.00 for that work. **Motion by Cox, support by Hulett to reimburse Baxtresser \$45.00 for the Brick engraving. Motion carried 5-0.**

D. Historical Markers-

- 1. Stuart Little Laser Etched Stone- The laser etching of the granite is complete. Baxtresser showed a photo of the completed stone. Installation of plaque will be in the spring. Scott offered to help with the installation. Baxtresser presented the Invoice from Ashcraft Engraving for \$ 320.00 for this work. Referencing the June 17, 2017 meeting's motion to approve this amount; Motion by Cox, support by Scott to reimburse Baxtresser \$ 320.00 for the Etching of the Stuart Little Granite, Motion carried 5-0.
