### EMERGENCY PREPAREDNESS COMMISSION "TIP OF THE MONTH"

The following Tip of the Month was read by Emergency Preparedness Commission Member Philip Mintz:

### MARCH 2016 EMERGENCY PREPAREDNESS COMMISSION TIP OF THE MONTH

This month the Farmington Hills Emergency Preparedness Commission is emphasizing knowledge and preparedness for weather and tornado-related events.

In Michigan, most tornadoes occur in April, May, June and July, usually between 3 and 7 p.m. Oakland County ranks third highest in Michigan for the number of tornadoes. To alert residents when a tornado has been sighted, Oakland County has more than 200 outdoor warning sirens, nine of which are located in Farmington and Farmington Hills.

Oakland County activates the siren system either when radar indicates severe weather conditions are present, when an actual tornado or funnel cloud is sighted or when wind speeds are 70 mph or higher. The sirens are only activated for these specific weather conditions, not for any other reason except testing.

Testing of the warning system occurs on first Saturday of each month at 1:00 p.m. during the months of May through November.

March is a good time for you and your family to have a tornado drill. You should have your 72-hour kit ready – including a battery operated radio – to take to your basement, or other designated area in your home.

Try to make the drill a fun family event. Practice your drill as a family or household group. Perhaps you could go out for a treat afterwards, or give prizes to children who know what to do.

Councilmember Bridges commented that requests for employment under Section 10.01A seem to come before Council every couple of months and the requests are typically from the same department.

City Manager Boyer explained that the Special Services Department employs between 200-400 part-time employees throughout the year and it is a challenge to employ that many people on a part-time basis to fill the positions.

Bryan Farmer pointed out that they have a great e-mail system in which the job postings go out to everyone in the city and many times the applicants are related to employees; but not necessarily within their own department. He agreed that they struggle to fill the part-time positions and send the notices out to colleges and to various associations; but they are always looking for people to work part-time in the parks, camps, etc., so any help in getting the word out would be appreciated.

### CONSENT AGENDA ITEMS FOR DISCUSSION:

Councilmember Lerner commented that Cadillac Asphalt was the same contractor that was awarded the Farmington Road rehabilitation project, and he had some concern with the condition the road and how that was left during the project, which was in conflict with the contract terms; and he feels they did not do an adequate job in serving the citizens of the community or responding to inquiries or concerns by the City. He suggested disqualifying them for this project and awarding the project to the 2<sup>nd</sup> low bidder.

Mayor Pro-Tem Knol acknowledged that Cadillac was also being awarded another project this evening.

Mr. Lerner stated that he does not have an issue with the quality of work as completed by Cadillac Asphalt, but had some concerns with the condition of the roads during the project. He felt that by awarding them the one project, the city is still allowing them to work within the city; but should not be awarded this large of a project when the 2<sup>nd</sup> low bidder is so close in price.

Jim Cubera, City Engineer, agreed that they had some challenges with the Farmington Road project, but he would still consider Cadillac Asphalt a good, qualify firm. He suggested that the contractor have an opportunity to speak with staff about any concerns or address Council before they were disqualified.

Councilmember Bruce inquired about legal ramifications for disqualifying a contractor.

Attorney Joppich stated that there is no contract in place at this time and the City has the right to choose the best contractor for the project and the City. He suggested that before taking action to award the bid to another contractor that the Council could consider postponing the issue to obtain more information if there is not a timing issue to start the project so that the City can give its due diligence to the issue.

Discussion continued with regard to issues with the Farmington Road project. Mr. Cubera noted other projects the company has completed within the City.

MOTION by Bruce, support by Lerner to postpone Consent discussion Item #15, Consideration of award of contract for the Colfax Street And Gill Road Reconstruction and CDBG Sidewalk Project to Cadillac Asphalt, LLC in the amount of \$1,698,924.96, to the March 28, 2016 City Council meeting.

### **PUBLIC OUESTIONS AND COMMENTS:**

Dan Irvin, Chamber of Commerce Executive Director, mentioned that the Chamber is financially stronger than at the beginning of 2015 and they have added more member benefits. One focus for 2016 is economic development and the retention of current businesses within the communities. He stated that the Chamber has partnered CGI Companies, a video production company out of Rochester, NY to shoot four videos throughout the communities on April 19<sup>th</sup> and 20<sup>th</sup> focusing on economic development, relocation and housing, chamber benefits and a welcome to Farmington/Farmington Hills. Mr. Irvin mentioned that the Chamber also has a new website and these videos will appear on the homepage. They will also provide for live streaming of videos when they are at events, including City Council meetings if that is allowed. They are hoping to launch a community marketing committee from these videos. He thanked the Mayor and Council and staff for being supportive of the Chamber over the last year.

Laurie Savin, West Bloomfield, spoke of her candidacy for Oakland County Circuit Court.

### **PUBLIC HEARINGS:**

PUBLIC HEARING AND CONSIDERATION OF ADOPTION OF A RESOLUTION CONFIRMING THE ASSESSMENT ROLL FOR BRIAR HILL SUBDIVISION ROAD REHABILITATION PROJECT, SPECIAL ASSESSMENT DISTRICT C-346, AND ESTABLISH THE TERMS OF THE ASSESSMENT PERIOD. CMR 3-16-13

Director Mekjian stated that on February 22, 2016, City Council set this public hearing date to consider project costs for the Briar Hill Subdivision road rehabilitation project and on March 2, 2016, city Engineering staff hosted an open house for residents to review the proposed project and how the construction may affect their property. He noted that approximately 36 of the 130 home were represented at the open house. Mr. Mekjian explained that bids for the project were advertised and opened and the total project cost based on bids received is proposed to be \$1,890,999.07 and a single unit assessment cost of \$9,380.00, which is less than the \$11,000.00 represented at the hearing of determination last fall.

City Council is being asked to adopt a resolution that would set the payment terms to be decided by Council at either 10 or 15 years and confirm the assessment roll as presented.

Mayor Massey opened the public hearing.

Polina Inger, Old Bedford, questioned the interest rate on the loan and if the residents will know their exact costs before the project starts.

Mayor Massey stated that the single unit assessment is proposed to be \$9,380.00 and tonight is when Council is considering the costs and final assessment roll for the project.

Pat Alzady, Beacontree, stated that she heard there was an outstanding lawsuit against Nagle Paving for mishandling debris and causing basement flooding and is curious whether that was taken into consideration. She asked what the costs would be for a corner lot and asked for clarification regarding the comment made that Nagle Paving was not a certified company.

There being no further comments, Mayor Massey closed the public hearing.

City Manager Boyer stated that the interest rate proposed is a 10 year assessment at 5% or a 15 year assessment at 5.5%. He confirmed that any such lawsuit does not involve Farmington Hills.

Attorney Joppich confirmed there is no such lawsuit in Farmington Hills and that issue would actually pertain to the award of the bid, which is being considered later on the agenda.

Mr. Boyer clarified that the comment made was that Nagle Paving Company is not certified in asphalt production and there are two companies from which companies such as Nagle purchase their asphalt.

City Engineer, Jim Cubera, stated that interior corner lots would not exceed 1.3 units of assessment.

Councilmember Bridges inquired about the construction, installation of speed humps and sewer improvements.

Mr. Cubera explained the construction layers and confirmed that the speed bumps that were removed would be re-installed. He stated that anytime the City has a road project, they review the infrastructure as part of that and any improvements would be paid out of the city sewer/water fund.

MOTION by Knol, support by Steckloff, that the City Council of Farmington Hills hereby adopts the resolution establishing the assessment period for 10 years and confirming the assessment roll

for the Briar Hill Subdivision Road Rehabilitation Project, Special Assessment District C-346, based on the property owner's share of the cost of the project and as presented to City Council on March 14, 2016, and

Councilmember Bridges inquired why Mayor Pro-Tem Knol was proposing the 10 year payment terms.

Mayor Pro-Tem Knol responded that in the past, Council has approved a 10 year assessment for similar amounts and the 15 year assessment would be at a higher interest rate costing residents more money overall.

Councilmember Rich inquired if there is a pre-payment penalty. Mayor Massey stated there is not.

Finance Director Gajda explained that with any special assessment the property owners would have an opportunity to pay the assessment off in full without interest for a short period of time and after that, interest would be charged; but they could still pay it off at any time throughout the 10 or 15 years to reduce their interest costs. In answer to Councilmember Rich, he stated that he does not believe the interest fee is deductible.

Councilmember Bruce inquired if there is any detriment to the city choosing between the 10 and 15 year assessment.

Director Gajda stated that there is not as the city will issue bonds for the project identical to the terms of the assessment. The interest rate on 15 years would be slightly higher and the advantage to the homeowner would be that their annual payment would be less; however, their overall payment would end up being higher.

Mayor Pro-Tem Knol inquired roughly how many people typically pay their assessment off in full without interest. Mr. Gajda estimated no more than 5%.

Councilmember Bridges inquired about the financial assistance programs. Mr. Gajda explained that the City has a deferment program for which a property owner must qualify.

Councilmember Bruce stated that he would prefer the 15 year payment terms since this is a special assessment initiated by the City rather than by resident petition and to also provide the residents a longer time frame in which to pay off the assessment. Councilmember Bridges concurred.

Mayor Massey stated that he does not recall any road project being assessed for more than 10 years and questioned if the city starts bonding projects over 15 years, could the debt incurred potentially harm the City's AAA bond rating.

Mr. Gajda responded that he does not feel there a concern at this time as the city has such a limited amount of debt. The important part is to only bond for a period of time that is no longer than the useful life of the road. If the city continues to approve SAD projects over the next 5 to 10 years, there could be an issue of outstanding debt down the road, and that is something that should continually be reviewed.

Discussion ensued on the payment terms, interest rates, etc.

CONSIDERATION OF APPROVAL OF AN INTRODUCTION OF AN ORDINANCE TO AMEND CHAPTER 2 OF THE CODE OF THE CITY OF FARMINGTON HILLS, "ADMINISTRATION," ARTICLE III, "GOVERNMENTAL ORGANIZATION," "APPROVAL OF LEGAL DOCUMENTS," TO AMEND THE AUTHORITY FOR EXECUTION OF LEGAL DOCUMENTS ON BEHALF OF THE CITY. CMR 3-16-14

Director of Finance Dave Gajda explained that new federal grant regulations required all federal grant reimbursement requests to be certified by someone who can legally bind the city and currently only the City Manager can legally bind the city. He noted that given the nature and extent of the grants received every year, he is recommending this Ordinance that would expand the list of who can legally bind the city to the City Manager, Assistant City Manager and the applicable Department Director that would be managing the grant.

Attorney Joppich clarified that the proposed recommendation in the report was to also set a public hearing; however, this is an amendment to the City Code and does not require a public hearing.

MOTION by Bridges, support by Knol, that City Council hereby approves the Introduction of an Amendment to the Administration Ordinance to amend Chapter 2 of the Code of the City of Farmington Hills, "Administration," Article III, "Governmental Organization," "Approval of Legal Documents," to amend the authority for execution of legal documents on behalf of the City.

# CONSIDERATION OF APPROVAL OF AN INTRODUCTION OF AN ORDINANCE TO AUTHORIZE THE LEASING OF CITY LAND TO OAKLAND COUNTY, NEW PAR, D/B/A VERIZON WIRELESS AND OTHER WIRELESS TELECOMMUNICATION SERVICE PROVIDERS. CMR 3-16-15

Director of Central Services Michael Lasley explained that back in December, Council approved leasing of space at the water tower and as a result of that, we were notified that an ordinance was required authorizing the City to lease the space and this is the first reading of that ordinance. He noted that the Oakland County Water Resource Commission signed off on the agreement since they own and finance the water tower and the city is waiting for signing of the agreement by Verizon, and it is anticipated this will be done within the next 30 days.

Councilmember Bridges inquired about the lease abatement payment in the amount of \$33,000 to Verizon.

Mr. Lasley explained that this was previously mentioned to City Council and was approved by the previous City Manager to offset costs that Verizon would occur to move from the lattice tower to the water tower.

Mr. Lasley noted that the City will receive approximately \$34,000 per year in revenue.

MOTION by Lerner, support by Rich, that the City Council of Farmington Hills hereby approves the Introduction of Ordinance to authorize leasing of City land to Oakland County, New Par, D/B/A Verizon Wireless, and other wireless telecommunication service providers.

### CONSIDERATION OF APPROVAL OF THE DISSOLUTION AND LIQUIDATION AGREEMENT RELATING TO SOUTHWESTERN OAKLAND CABLE COMMISSION (SWOCC). CMR 3-16-16

City Manager Boyer stated that at the study session meeting of February 22, 2016, City Council reviewed the agreement with SWOCC and the possible dissolution of SWOCC in light of the City of Novi notifying the parties that they wished to remove themselves from the Commission. The SWOCC Board passed a motion in November to consider the dissolution of SWOCC.

Mr. Boyer noted that the services would continue by each entity on its own and Channel 8.1 would continue and the city cable staff involved would remain and provide for those services out of another building and the SWOCC building and other assets would be sold and divided based on the proposed agreement.

Mayor Massey stated that this issue has been discussed both at study session meetings and by the SWOCC Board for a while and the services will still be provided but adapting to changes in technology and this would be the dissolution of the Commission as it currently stands.

MOTION by Knol, support by Bridges, that the City Council of Farmington Hills hereby approves the Dissolution and Liquidation Agreement relating to Southwestern Oakland Cable Commission (SWOCC).

### CONSIDERATION OF APPROVAL OF A RESOLUTION DESIGNATING AN ACTING CITY MANAGER IN ACCORDANCE WITH SECTION 3.07B OF THE CITY CHARTER. CMR 3-16-**17**

Attorney Joppich explained that the Charter calls for the designation of an Acting City Manager in the absence of the City Manager and the currently the Acting City Manager is the newly appointed City Manager so Council is being asked to consider this resolution that would designate Assistant City Manager Gary Mekjian as the Acting City Manager.

Director Lasley stated that the request is to award proposals for Type I and II ambulances and in the city's continued effort to conduct cooperative purchasing, this is he believes the first ever cooperative bid for ambulances in the State and was coordinated by the City of Farmington Hills and includes the City of Rochester Hill and Warren and Townships of Northville and Commerce. It is expected that initially 18 vehicles will be ordered with 6 identified in the report for Farmington Hills. It is proposed to award the contract to the lowest competent bidder, Mercy Sales. Four (4) of the vehicles were included in the 2015/16 Capital Improvement Program (CIP) budget and two (2) of the vehicles are included in the proposed 2016/17 CIP budget. Existing vehicles would be traded in to offset some of the costs.

Councilmember Lerner stated that the City was using refurbished ambulances to save money and questioned if the city was doing that any longer.

Fire Chief Unruh stated that to his knowledge, the City is no longer using the refurbished model and what is proposed is a new model vehicle that would be much easier to work on as they have stock parts and they are able to get more mileage out of the new, medium-duty ambulances. He confirmed the plan is to keep the vehicles for 5 years and they can either rotate them or have them rotate out at the same time.

Director Lasley stated that staff talked to the manufacturers about the concept of using the existing box and putting that on a brand new chassis; but the reviews are mixed as the vehicles are heavily used and some of the performance is lacking and technology changes so quickly.
