5. UNFINISHED BUSINESS:

A. Museum Accession/De-Accession Reviews: Lee cox presented the Commission with a "Title Abstract" from a property located on Griggs Street (now named Grayling).

MOTION by Baxtresser, support by Cox, to accept the Title Abstract into the collection at the Heritage and History Center. Motion carried 6-0.

B. Museum Improvement-

- 1. Interior- Preliminary thoughts about constructing a stairway to the basement, underneath the existing second floor stairway, were discussed. This would be "Phase One" in a larger project to later incorporate the unused empty space into usable museum space or archival storage. Exploratory quotes for this work will be pursued.
- 2. Exterior a. Exterior landscaping was discussed. Brian Golden had set out the two quotations for this work previously obtained by Scott. The plan devised by Betty Poole was discussed and was not in the package and will need to be reviewed. Baxtresser had mentioned that he had a meeting with Ellen Schnackel and William

Wright about the possibility of assistance from Special Services in plant removals around the HHC Building. They mentioned that they would be willing to provide assistance.

- C. Brick Walk Brick Sales- Baxtresser informed the Commission that he had discussed, with Ellen Schnackel, the placing of an informational notice in the Special Services Activities Guide about the Brick Paver Project.
- D. Historical Markers-
 - 1. Stuart Little Laser Etched Stone- Baxtresser mentioned that the etched granite was delayed with scheduling difficulties with the providing contractor.
 - 2. Pasadena Park- On hold.
 - 3. Palmer Sherman House- Deed information is needed. On Hold.
 - 4. Pursuant to an email from Mark Stec, the poles for the Sleepy Hollow Sign would need some modifications. Cox and Baxtresser said they would be able make these modifications so the City Sign Shop would be able to install the sign. It was further discussed about the necessity of contacting Commissioner Cox for coordination details about the final sign installations.
