PRESENTATION ON COMMUNITY CENTER RENOVATIONS AND RECOMMENDED APPROVAL OF AWARD OF CONTRACT FOR ARCHITECTURAL AND ENGINEERING SERVICES TO INTEGRATED DESIGN SOLUTIONS IN THE ESTIMATED AMOUNT OF \$1,125,000. CMR 10-18-89

Director of Special Services, Ellen Schnackel, indicated that the next step in the process to convert Harrison High School to a community center was to recommend an award of contract for architectural and engineering services for the project. She introduced Andrew Fountain of Plante Moran Cresa, the City's Owner's Representative for the project.

Mr. Fountain, Plante Moran Cresa, stated that they are serving as the Owner's Representative for this project and will act as the city's fiduciary to assist and advise the city throughout the project. He stated that they are recommending Integrated Design Solutions (IDS) for the award of contract for architectural and engineering services and outlined the process on how the firm was selected.

Mark Reaves, Assistant Director of Architecture at IDS, explained that IDS is a full service firm out of Troy Michigan with another office in Grand Rapids and they specialize in many market segments including workplace, corporate, community and higher education. He is a resident of Farmington Hills and is excited to work on a project that he will utilize as a community member.

MOTION by Lerner, support by Bridges, that the City Council of Farmington Hills hereby authorizes the City Manager to sign a contract for Architectural & Engineering Services for the Community Center Renovation with Integrated Design Solutions for all fees based on 7.5% of the current construction budget of approximately \$15 million (or a current estimated amount of \$1,125,000), pending final review and approval of terms by City of Farmington Hills legal counsel.
