EMERGENCY PREPAREDNESS COMMISSION TIP OF THE MONTH

The following Tip of the Month was read by Keith Ciaramitaro, EPC Chairperson:

Water

Purchase and store 72 Hour supply of water that is sealed.

Water is vital in a disaster

It doesn't matter if you get your water from a municipal water system or your home has a private well, your water supply depends on having power to operate the system. During a power outage—or any disaster that can cause a power outage, such as high winds, ice storm, or flood—you may find yourself without drinkable water.

APPROVED 2/25/2019

A three day supply for 1 person is about 3 gallons of water. Plan for 3 gallons per person in the household, as well as 1-2 gallons of water for each pet (size dependent larger animals such as horses may require more speak with your vet).

Make sure you stay hydrated

During an emergency you should drink about 2 quarts a day, and adjust for special dietary needs. If you require more or less water due to dietary needs your supply should be adjusted.

Restocking your water

To keep the stored water from becoming contaminated or expired, you should replace it once per year. A great idea is around summer to use it for an event after you replace the old bottles.

CONSENT AGENDA ITEMS FOR DISCUSSION

RECOMMENDED APPROVAL OF CONTRACT FOR CONSTRUCTION MANAGER AS CONTRACTOR SERVICES FOR THE COMMUNITY CENTER RENOVATION TO COLASANTI CONSTRUCTION SERVICES IN THE ESTIMATED AMOUNT OF \$992,248. **CMR 2-19-10**

Councilmember Lerner asked Colasanti Construction to address the claim from Great Lakes Water Authority (GLA) regarding a default on a contract.

Scott Meredith, representing Colasanti, explained that there is no legal proceeding in this matter, but a declaration of default that was made 4 years after they reached substantial completion of the installation of a sludge collection system at the southwest water treatment plant. GLWA indicated they were having design issues with the system 4 years later and they are contesting it is due to the installation and Colasanti is contesting that it is due to lack of maintenance.

MOTION by Lerner, support by Knol, to approve Consent Agenda Item #11, the contract for Construction Manager as Contractor Services for the community center renovation to Colasanti Construction Services in the estimated amount of \$992,248, per CMR 2-19-10. MOTION CARRIED 7-0.

PUBLIC QUESTIONS AND COMMENTS

Gary Gozmanian, Windmill Court, stated that he is also representing several other neighbors regarding construction noise in the area from Kaufman Financial Center on Northwestern Highway who they feel is violating city noise ordinances on a weekly basis. He added that someone from the business had trespassed on his property to climb his tree and cut a branch that was hanging over onto their property.

City Manager Boyer asked the resident to provide his contact information to Assistant City Manager Mekjian so the city could assist in resolving these issues.

Kathy Brown, Rocky Crest,, expressed concern with the abundance of deer in her yard and questioned the results from the survey that was provided to residents asking them what they thought should be done to address the deer population.

Mayor Massey stated that the survey results overwhelming were not in favor of killing the deer. He added that this this is a regional issue that the city has been trying to get assistance from the Michigan DNR with little luck to date.

COUNCIL MEMBERS COMMENTS AND ANNOUNCEMENTS

The following comments/announcements were made:

- Councilmember Rich commented on a couple of ride-a-longs; one with the Police Department and another on a slow plow with DPW and she congratulated staff on their hard work and the way that the Police and Fire worked together on scene and connected with neighbors to keep residents safe. She also thanked the city for purchasing new chairs for Dispatch.
- Mayor Pro-Tem Bridges mentioned a Business Outreach Program being held at City Hall on Monday, February 25, 2019 from 9am-11am; and that the Commission on Aging is seeking nominations for volunteer service awards in the community. The nominees must be 50+ to be eligible.

WHEREAS, as part of its 2018 goals session, City Council discussed issues pertaining to the availability and affordability of broadband for families and businesses in the City, the lack of competition in the City, the importance of broadband services in today's world, and the idea of forming a committee or work group consisting of residents, business owners and subject matter experts to look into the concept of municipal broadband; and

WHEREAS, on May 14, 2018, City Council adopted a resolution (R-62-18) establishing the Broadband Task Force for the purpose and with the objective of studying and reporting to City Council any available options and the necessary undertakings in order to establish a municipal broadband system and services in the City of Farmington Hills, potential obstacles or issues involved with doing so, and the possibility of public-private partnerships and interlocal partnerships for the provision of municipal broadband services.

WHEREAS, the Task Force was provided an expiration term of February 1, 2019, unless its term was extended by City Council.

WHEREAS, as the Task Force requires more time to carry out its purpose and objectives and to provide a report to City Council, it is requesting a 6 month extension from its original expiration date.

RECOMMENDED ADOPTION OF THE NOTICE OF INTENT RESOLUTION FOR CAPITAL IMPROVEMENT BONDS FOR THE RENOVATION OF COMMUNITY CENTERS. CMR 2-19-08

Steve Barr, Finance Director, explained that before Council this evening is a Notice of Intent Resolution for capital improvement bonds for the renovation of community centers that was discussed at a previous City Council study session meeting.

He explained that the City is purchasing Harrison High School and converting that into a community center and the existing Costick Activities Center is also in need of repair. The resolution is a notice of the intent to issue capital improvement bonds for these projects in an amount not to exceed \$25 million. The final amount of the bonds will be based on the city's project costs based on the bids received. This resolution does not authorize the city to issue bonds; such resolution will come back to city council at a future meeting for consideration.

City Manager Boyer added that funds were included in the resolution for renovations at the Costick Activities Center at the direction of Council during the study session meeting so that the funding would be available if the city determined to move forward with those renovations.

Mayor Massey commented that this item would have normally been considered as part of the Consent Agenda, but there was a request via e-mail to remove it from the consent agenda to provide for discussion.

NOTICE OF INTENT RESOLUTION CAPITAL IMPROVEMENT BONDS FOR COMMUNITY CENTER

Minutes of a regular meeting of the City Council of the City of Farmington Hills, County of Oakland, State of Michigan, held on the 11th day of February, 2019, at 7:30 o'clock p.m. prevailing Eastern Time.

The following preamble and resolution were offered by Member Lerner and supported by Member Bridges:

WHEREAS, the City of Farmington Hills, County of Oakland, State of Michigan (the "City"), intends to authorize the issuance and sale of one or more series of general obligation limited tax bonds pursuant to Act 34, Public Acts of Michigan, 2001, as amended ("Act 34"), to pay all or part of the cost to acquire, construct, furnish and equip one or more community centers, including demolition, site improvements and all related appurtenances and attachments (the "Project"); and

WHEREAS, the total amount of bonds to be issued to finance the acquisition and construction of the Project shall not exceed Twenty-Five Million Dollars (\$25,000,000); and

WHEREAS, a notice of intent to issue bonds must be published before the issuance of the aforesaid bonds in order to comply with the requirements of Section 517 of Act 34; and

WHEREAS, the City intends at this time to state its intention to be reimbursed from proceeds of the Bonds for any expenditures undertaken by the City for the Project prior to issuance of the Bonds.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The City Clerk is hereby authorized and directed to publish a notice of intent to issue the Bonds in the *Farmington Press*, a newspaper of general circulation in the City.
- 2. The notice of intent shall be published as a **display advertisement not less than one-quarter (1/4) page in size** in substantially the form attached to this Resolution as Exhibit A.
- 3. The City Council does hereby determine that the foregoing form of Notice of Intent to Issue Bonds, and the manner of publication directed, is adequate notice to the taxpayers and electors of the City, and is the method best calculated to give them notice of the City's intent to issue the Bonds, the purpose of the Bonds, the security for the Bonds, and the right of referendum of the electors with respect thereto, and that the provision of forty-five (45
- 4.) days within which to file a referendum petition is adequate to insure that the City's electors may exercise their legal rights of referendum, and the newspaper named for publication is hereby determined to reach the largest number of persons to whom the notice is directed.
- 5. The City makes the following declarations for the purpose of complying with the reimbursement rules of Treas. Reg. § 1.150-2 pursuant to the Internal Revenue Code of 1986, as amended:
 - (a) The City reasonably expects to reimburse itself with proceeds of the Bonds for certain costs of the Project which were paid or will be paid from funds of the City subsequent to sixty (60) days prior to today.

- (b) The maximum principal amount of debt expected to be issued for the Project, including issuance costs, is \$25,000,000.
- (c) A reimbursement allocation of the capital expenditures described above with the proceeds of the Bonds will occur not later than 18 months after the later of (i) the date on which the expenditure is paid, or (ii) the date the Project is placed in service or abandoned, but in no event more than three (3) years after the original expenditure is paid. A reimbursement allocation is an allocation in writing that evidences the City's use of the proceeds of the Bonds to reimburse the City for a capital expenditure made pursuant to this resolution.
- 6. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are hereby rescinded.

WHEREAS, The City is acquiring the Harrison High School property with the intention of redeveloping, remodeling and using the building and property as a community recreation, activities and cultural arts facility (the "Center"), with programming and uses similar to (but increased given the addition of the extensive and sizable facilities on the premises) what the City of Farmington Hills Special Services Department presently provides, as well as other City-sponsored, public or municipal uses; and

WHEREAS, Prior to entering into the Purchase Agreement with the School District, representatives of the City reached out to and engaged in a dialogue with the Harrison Legacy Committee (the "Committee"), which is a privately organized and established group of citizens who want to preserve the legacy of Harrison High School after its closure, in order to discuss the City's plans for the property as described above; and

WHEREAS, As part of that dialogue, the City's representatives have informed the Committee of the City's plan and desire to preserve the legacy and heritage of the high school in the community by including, as part of its redevelopment and transformation of the High School into the Center, one or more areas within the future Center where trophies and other memorabilia of Harrison High School will be maintained and placed on display by the City for public viewing and to also retain and maintain Herrington Plaza; and

WHEREAS, The School District has expressed its like-minded desire for some level of preservation of the legacy and heritage of the high school in the community after its closure, and the School District and City included a provision in the Purchase Agreement to provide for the adoption of this City Council Resolution expressing the City's plans for continuing its dialogue with the Committee and its intended preservation efforts.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the City Council of the City of Farmington Hills declares the following:

(1) During the process of its acquisition and development of plans for its renovation and transformation of the current Harrison High School into a City-owned and operated Center after the school closes in 2019, the City will continue its efforts to work with the Committee for purposes of receiving input and information from the Committee regarding the identification of one or more areas within the future Center where some of the trophies and other memorabilia of Harrison High School can be maintained and placed on display by the City for public viewing in order to preserve the legacy and heritage of said high school in the community.

(2) The City also intends to retain and maintain the Herrington Plaza located on the current Harrison High School as part of preserving the Harrison High School legacy in the community.
