Planning and Community Development Director Gardiner stated that on November 25, 2013 City Council approved a Planned Unit Development (PUD) for the redevelopment of the Orchard 12 Plaza located on the northwest corner of 12 Mile and Orchard Lake Road. The City Attorney along with the attorney for the developer has submitted this agreement for Council's consideration and approval. Director Gardiner stated that this was also his understanding and that the developer is looking for a new tenant for that building.
