  - a. Interior-Baxtresser and Scott informed the commissioners of the design progress meeting on May 20, 2022, with the architect, Stuart Pettitt and Grace Clifford, as well as Brian Monacelli of the Special Services Department. The architect, per their contract with Special Services, has delivered a set of Design Drawings for the improvements to the Heritage and History Center that accommodates the requirements the FHHC had requested at the design onset. The two key issues:

    - 2. Providing ADA access to the building.

Monacelli directed the architect to generate a construction budget. Monacelli mentioned that all budget funds were closed for the current year, and this would flow into next year's budgeting.
