PUBLIC QUESTIONS AND COMMENTS

Marcia Gershenson, County Commissioner, mentioned the following:

She will be holding an informational meeting on Tuesday, May 18, 2021 at 5pm to talk about the first round of the Federal American Rescue Plan Funding of \$244 million that has been allocated to Oakland County.

This allocation is different than last year's CARES funding because Cities, Villages and Townships will also be receiving \$155 million in stimulus money.

Commissioners are working with County administration to develop a plan to maximize the impact of these funds to make transformative investments in our community. She is reaching out because leveraging these funds in partnership with our state and local governments is a key strategy in the County's plan.

They are expecting to receive the Treasury department criteria for the allocation of the dollars this week. Chief Deputy Chris Ward will be on the call to answer any questions.

When elected leaders and staff are talking about infrastructure improvements, please remember, the County might be able to share some of your expenses.

The invite for the meeting on May 18 will go out this week.

Tom Callahan, resident, questioned a resolution relating to the City's road millage and Act 51 funding. Mayor Barnett and Councilmember Knol offered some history on this topic and provided an explanation of the intent of the resolution.

Mr. Callahan asked that a copy of the resolution is sent to him and outlines where it is tied to the passing of a state-wide initiative.

Councilmember Knol stated that she would send Mr. Callahan a copy as well as a copy of an article she mentioned from the Observer that covered the meeting where this was discussed and outlined the city's intent.
