# **COMMUNICATIONS, PROMOTIONS AND WEBSITE:**

### **EDUCATION COMMITTEE:**

- Weglarz reported on the Person Centered Response to Elder Exploitation training session that
  was held on May 14. Fantore, Weglarz and McCowan attended with 14 Farmington Hills
  detectives.
- McCowan shared that the policemen provided good feedback and agreed elder exploitation is a
  serious issue in Oakland County. There are no prosecutors that are specifically assigned to elder
  exploitation cases and some prosecutors are hesitant to act. Research shows that family
  members are usually responsible for financial exploitation of the elderly. This is done through
  joint accounts and power of attorney appointments.
- Another workshop is planned for fall, 2021. AAA1B is interested in the issue. McCowan continues her education on this issue.
