#### **NEW BUSINESS**

CONSIDERATION OF APPROVAL OF THE INTRODUCTION OF AN ORDINANCE TO AMEND THE FARMINGTON HILLS CITY CODE BY AMENDING CHAPTER 2, "ADMINISTRATION," ARTICLE IV, "BOARDS, COMMISSIONS AND COUNCILS," DIVISION 8, "FARMINGTON AREA ARTS COMMISSION," SECTION 2-222, "PURPOSE" TO UPDATE THE PURPOSE OF THE COMMISSION, AND DIVISION 9, "COMMISSION TO INCREASE VOTER PARTICIPATION" TO CORRECT THE COMMISSION NAME.

City Clerk Smith explained that the proposed amendment was to update the purpose statement included in the ordinance for the Farmington Area Arts Commission and to correct the name for the Committee To Increase Voter Participation that inadvertently named the "Commission" To Increase Voter Participation when the ordinance was adopted.

Councilmember Rich suggested a change to Section 2-231 of the ordinance to keep language that this is a duly organized and established city "commission" having the name "Committee" To Increase Voter Participation.

Attorney Joppich confirmed that the suggested change would maintain consistency with the City Charter and also maintain the name that has been used for the group since it was first formed.

MOTION by Rich, support by Bruce, that the City Council of Farmington Hills hereby approves the Introduction of an Ordinance to amend the Farmington Hills City Code by amending Chapter 2, "Administration," Article IV, "Boards, Commissions and Councils," Division 8, "Farmington Area Arts Commission," Section 2-222, "Purpose" to update the purpose of the Commission, and Division 9, "Commission to Increase Voter Participation" to correct the Commission name, with an amendment to the last sentence in Section 2-231 to read, "The city hereby ratifies and continues the existence of this committee under this Code as a duly organized and established city commission having the name committee to increase voter participation and the purposes set forth below".
