## <u>PUBLIC HEARING AND CONSIDERATION OF ADOPTION OF A RESOLUTION</u> APPROVING THE BROWNFIELD PLAN FOR 24205 ORCHARD LAKE ROAD, CMR 8-20-87

Samantha Seimer, Economic Development Director, reviewed the proposed Brownfield plan with tax increment financing for property located at 24205 Orchard Lake Road. The plan includes a new gas station and retail component. The property has sat vacant for the past 7 years and the proposed development will create many new jobs in the area and alleviate the environmental concerns for the site. She noted that the developer has requested a 90 day look-back period due to COVID, which was supported by the Brownfield Development Authority.

Mayor Barnett opened the public hearing. There were no comments from the public.

Councilmember Boleware inquired about the downside if this plan were not approved. The downsides noted would be the lack of any development on the site and there would still be environmental concerns on the site that would need to be addressed, which is the reason it has not been developed to date.

Discussion was held on the capture of tax funding.

It was questioned if City Council would see a PUD plan for this property as there was some concern as to the traffic pattern affecting businesses to the north and south.

Director Seimer responded that the development was approved as part of a site plan in 2019 and not a Planned Unit Development (PUD).

WHEREAS, the Brownfield Redevelopment Authority (the "Authority") of the City of Farmington Hills (the "City"), pursuant to and in accordance with the provisions of the Brownfield Redevelopment Financing, Act, being Act 381 of the Public Acts of the State of Michigan of 1996, as amended (the "Act"), has prepared and recommended for approval by the City Council of the City (the "Council"), a Brownfield Plan (the "Plan") pursuant to and in accordance with Section 13 of the Act; and

WHEREAS, the City Council held a public hearing on proposed Brownfield Redevelopment Plan for (the "Plan") for the property located at 24205 Orchard Lake Road, Farmington Hills, MI 48336 (the "Property") following the publication of notice in the manner required by Section 13(10) of the Act; and

WHEREAS, the City has, at least ten (10) days before the public hearing, provided notice of the public hearing to the taxing jurisdictions affected by the Plan which levy taxes subject to capture under the Act (the "Taxing Jurisdictions") and have informed such Taxing Jurisdictions about the fiscal and economic implications of the proposed Plan, and the Council has provided the Taxing Jurisdictions the right to be heard at the public hearing in accordance with Section 13(13) of the Act; and

WHEREAS, the Council has made the following determinations and findings:

- A. The Plan constitutes a public purpose under the Act;
- B. The Plan meets all of the requirements for a brownfield plan set forth in Section 13 of the Act;
- C. The proposed method of financing the costs of the eligible activities, as described in the Plan, is feasible and the Authority has the ability to arrange the financing;
- D. The costs of the eligible activities proposed in the Plan are reasonable and necessary to carry out the purposes of the Act;
- E. The amount of captured taxable value estimated to result from the adoption of the Plan is reasonable; and

WHEREAS, as a result of its review of the Plan and upon consideration of the views and recommendations of the Taxing Jurisdictions, the Council desires to proceed with approval of the Plan.

#### NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. <u>Plan Approved</u>. Pursuant to the authority vested in the Council by the Act, and pursuant to and in accordance with the provisions of Section 14 of the Act, the Plan is hereby approved in the form attached as Exhibit A to this Resolution.
- 2. <u>Severability</u>. Should any section, clause or phrase of this Resolution be declared by the Courts to be invalid, the same shall not affect the validity of this Resolution as a whole nor any part thereof other than the part so declared to be invalid.
- 3. <u>Repeals</u>. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

Concerns were expressed regarding the number of attendees and social distancing with such a large group.

Clerk Smith commented that the applicant is aware that they must adhere to the Governor's Executive Order and Police staff will be on site as they have requested Police assistance.

It was noted that other special events were approved by City Council under the same order and that the events should all be treated equally, and any concerns can be addressed during the event if required.

MOTION by Massey, support by Knol, that the City Council of Farmington Hills hereby approves a Special Event Permit for Motor City Harley Davidson located at 24800 Haggerty Road, Farmington Hills, for their Anniversary event to be held August 21, 2020 from 6pm to 9pm and August 22, 2020 from 10am to 8pm; subject to the following conditions:

- All COVID-19 sanitary and safety protocols must be followed
- The event must comply with current and future applicable Executive Orders issued by the State, County or City
- There will be live music during this event, with no stages or large speakers. The applicant has been advised of the noise ordinance and has assured that the noise level will not create a nuisance or generate complaints
- On-site outdoor participants will be limited to no more than 100 attendees
- There will be ample parking provided to those in attendance. Emergency access and all fire lanes will be accessible
- MCHD will have professional private security officers on scene for both days of the event
- MCHD has requested two Farmington Hills Police Officers and the applicant has agreed to reimburse the City for these services as outlined in the Department recommendations to the Clerk
- The event shall comply with minimum Fire Prevention Code requirements
- There will be no parking within 20' of the tent
- There will be no smoking within 500' of flammable or combustible liquid
- Tents must meet the NFPA 701 Standard and flame resistance label affixed to panels
- Food trucks shall be located a minimum of 10' from any structure

- Egress from the facility shall not be blocked or restricted
- Proponent must contact Fire Prevention to schedule an inspection prior to beginning the event
