- **1. CALLED TO ORDER BY:** Chairman Hulett at 7:38 p.m.
- **2. MEMBERS PRESENT:** Lee Cox, Earl Baxtresser, James Hulett, John Scott, Pam Correll, John Willyard.

3. APPROVAL OF AGENDA:

MOTION by Baxtresser, support by Scott, to approve the agenda as published. Motion carried 6-0.

4. APPROVAL OF MINUTES- June 13, 2018:

MOTION by Willyard, support by Correll, to accept the minutes of June 13, 2018 as written. Motion carried 6-0.

5. UNFINISHED BUSINESS:

- **A.** Museum Accession/De-Accession Reviews- Cox brought in a framed photo of a roadway collapse on Halsted and Grand River. **Motion by Baxtresser, support by Scott to accept this photo into the H&HC Collection. Motion carried 6-0.**
- B. Museum Improvement-

Interior-

a. Last month's motion by the Historical Commission to "Engage in a dialogue with The Special Services Department to consider improvements to the Heritage and History Center" has resulted in a meeting to be held on October 3rd at 1:00 p.m. at the Stables Art Studio in Heritage Park. This meeting will be to discuss the FHHC's vision and timeline of a Heritage and History Center improvement project.
 b. There was a discussion about the FHHC's Book Fund Account. Baxtresser mentioned that that account is not shown on the recently transmitted "FHHC Expenditure Detail Report". Cox said he would look into this before the next meeting.

Exterior-

2. Baxtresser presented a final tally for the expenses incurred performing the landscaping work at the H&HC. The amount exceeded the previously approved \$ 200.00 by \$ 24.55. Also, Baxtresser presented the materials expenses for the Stuart Little Granite Plaque installation for \$ 70.38.

Motion by Cox, support by Scott to reimburse Baxtresser for various expenses in the amount of \$ 294.93. Motion carried 6-0.

- **D.** Historical Markers-
 - 1. Stuart Little- There was a discussion about the Brigid Stolberg Bench at the H&HC. Motion by Correll, support by Baxtresser to further investigate options as to the relocation of the wooden bench or having the Special Services Department locate a "Parks and Recreation Style Bench" at the Stuart Little Pond for which the Historical Commission would furnish an appropriate plaque.
 - 2. Pasadena Park- On hold.
 - 3. Workers Camp Sign-Willyard mentioned that without a series of boulders surrounding the base of the sign, the sign was still vulnerable to damage by maintenance crews. Willyard also talked about the Historical Commission's willingness to repair Historic Markers, damaged by others, should be reconsidered.
 - 4. Palmer Sherman House- Deed information is needed. On Hold.
 - 5. The Pernambuco Hollow- Sign has yet to be reinstalled with the new poles purchased by the Historical Commission. Cox said he would contact Steve Dixon about this.
 - 6. Minnow Pond- Cox mentioned that the vegetation around the sign is beginning to block viewing of the sign. He mentioned he could explore some proactive options with the DPW for a remedy.
 - 7. Boys Republic-Scott inquired to the possibility of a Historic Marker at this site.
 - 8. Willyard talked about the importance of continued research for new possibilities for Historic Signage in Farmington Hills. As segments of the population age and younger populations grow into the community, the historic significances are always evolving.
