Interior Baxtresser shared email correspondence with Bryan Farmer of the Special Services Department in which the Mr. Farmer shares the review of the bidders and the final selection the A&E firm, Straub Pettit Yaste Architects, to perform the architectural services at the Heritage and History Center. This low bidder's fee was approved by City Council and that will trigger the \$10,000.00 commitment form the Historical Commission as approved by unanimous motion on June 12, 2019.

- **7. POINTS OF INTEREST:** Willyard shared a 2"x10" oak floor joist bridging element from his 1830's house. He explained how this piece demonstrated early 19th century vertical sawing kerf marks (predating circular saws) as well as the end of cut remnant wood left from this process.
