Stars in the Park Concert Series - 7 Concerts this Year – an estimated 3,100 people saw & heard outdoor music! Two cancellations: Atomic Radio due to rain. Farmington Community Chorus.

The SpongeBob musical – this summer! 60 kids cast, over 1,000 people attended a total of 4 performances.

Youth Theatre

Auditions for the Fall Youth Theatre productions took place at the end of August, rehearsals start next week! Descendants Junior -160 kids cast. Mamma Mia -55 cast.

Descendants Junior performs November 18-21, Mamma Mia December 2-5

Classes at The Hawk – Fall Guide is out! Dance and art classes. Music classes, still pending. Classes start the week of Sept 20. Hiring some really great teachers!

Exhibits

The Hawk - Art Gallery - Seen by thousands during Summer Camps, Fitness & Aquatics Events Challenges with the space! Paused hanging artwork in areas that don't have cameras.

Rentals – concentrating on programming for Theatre before it is opened for rentals.

PUBLIC ART COMMITTEE REPORT

Update from Mural Committee on study sessions with City Council and Attorneys. The Planning Commission and the FAAC are in agreement that murals should be for aesthetic enjoyment and not advertising for the business. Sign policy addresses this. Need further discussion on who will be the contact and advisors for businesses who meet the criteria. Councilwoman Boleware shared Council study session recommendation that the FAAC act as the advisory body. Next work meeting scheduled for September 15.
