#### POINTS OF INTEREST/UPDATES:

#### a. <u>Botsford Inn Update:</u>

Meeting with HDC subcommittee (Trafelet, Tulas and Thomson) and Beaumont Health System representatives held at Botsford Inn on 2/28/2022, including discussion and an interior and exterior tour.

A summary of history of the project and meeting results were prepared by Thomson and attached.

Olson added that when the demolition of Anhut additions were approved by the FHHDC in 2007 (at which time Olson was a Commissioner) it was, in part, conditioned upon the Botsford Inn being maintained and conversion of the facility to a respite for families of cancer patients in treatment at Beaumont. This conversion was started, but never completed and there is no evidence of ongoing maintenance. Interior and exterior are "in shambles". It does appear to be adequately enclosed to protect overall structure of the building.

Olson drafted a letter to Beaumont (copy attached) regarding the Botsford Inn status and requesting that Beaumont representatives attend the April 13, 2022 meeting to address concerns, in particular restoration of the exterior structures such that it will qualify for a Certificate of a Appropriateness and also a long term maintenance plan.

The Commission heartily approved submission of the letter to the appropriate Beaumont representatives with a cc to the Farmington Hills city attorney and signature of Jim Paulson, Chairperson, FHHDC.

\$5,000 per year to maintain and repair cemeteries will be included in FHHDC Annual Budget in perpetuity.
