RECOGNITION OF POLICE OFFICER, FIREFIGHTER AND EMPLOYEE OF THE YEAR

Director of Human Resources Brown noted that the City held its 47th annual Outstanding Employee Recognition and Service Awards at Longacre House on Thursday, July 25.

Director Brown introduced Michael Presson, Information Systems Analyst I in the City's Central Services Department, who was selected as Employee of the Year for his role in providing IT support to City employees, and particularly his leading role in the recent technology upgrade at the Police Department. Presson's proactive approach, patience, and dedication to teamwork have earned him the respect and admiration of his colleagues.

Fire Chief Unruh introduced Firefighter of the Year Sean Beacome. In 2023, Beacome revived the fall assembly program that had been paused due to multiple retirements and COVID-19. Beacome was able to leverage his experience as an educator to create age-appropriate fire safety messaging that was presented to more than 5,800 elementary school students in the Farmington Hills Public School District, Clarenceville School District, and private schools within the City. He was also instrumental in securing a \$10,000 grant to enhance the Department's response to electric vehicle-related emergencies. Beacome has led or assisted in 50 fire investigations since he began working with the Fire Marshal's Office in 2022.

Police Chief King introduced the 2023 Police Officer of the Year, Officer Alexander Aquiline. In 2023 Aquiline received two Life Saving Awards, including rendering aid to a victim who had 4 major stab wounds to his chest, and saving the life of a 72-year-old male lying unbreathing on the floor of his

apartment. In 2023 Officer Aquiline was also awarded four individual citations for meritorious service, two unit citations, and a letter of appreciation.

Employee of the Year Michael Presson, Firefighter of the Year Sean Beacome, and Police Officer of the Year Alexander Aquiline all thanked the City and Council for their support.

Director Brown recognized recipients of the 2023 Outstanding Employee Awards Paul Cischke, video production specialist in the Communications & Community Engagement Department, Brant Klassen, accounting specialist in the Finance Department, Barbara Smrtka, secretary to Director of the Public Services Department, and James (Jimmy) Vayis, facilities supervisor for the Special Services Department at The Hawk.

Director Brown also recognized Elsie Hellner, who has dedicated 35 years to the City and is the force behind Heritage Park and the visionary behind the annual holiday lights display at City Hall.

PRESENTATION OF APWA REACCREDITATION

Larry Hummel, Region 5 Representative for the American Public Works Association, presented the APWA Reaccreditation award to Director of Public Services Rushlow and Department of Public Works Superintendent Schueller.

Mr. Hummel said that accreditation is a mark of professionalism indicating a public works agency has made the commitment to continuous improvement in the delivery of public works, operations, and services in the community it serves. The Farmington Hills Department of Public Works has achieved 100% full compliance with all applicable practices and standards. In addition, the evaluators recognized a model practice that will be shared with the rest of the accredited agencies and those that are going through the study and accreditation process.

Director Rushlow said that the Farmington Hills Department of Public Services is one of 3 agencies in the State of Michigan to receive this designation, and the only City to do so. This is third consecutive year that the Department has received accreditation. Director Rushlow thanked Superintendent Schueller, who was the Accreditation Manager throughout the process.

CITY MANAGER UPDATE

City Manager Mekjian provided the following update:

- Congratulated the Department of Public Services on a job well done for their third APWA reaccreditation.
- Information is available on the City website www.fhgov.com regarding the Fiber City project, including a progress map and timeline for the project.
- Congratulated Fire Marshal Baloga for being recognized by the Consumer Product Safety Commission for an investigation into a wireless charging power bank that Fire Marshal Baloga discovered as part of a fire investigation in a city home. The investigation led to a nationwide recall of the power bank, and recognition of his efforts was covered by the local Fox 2 affiliate.

NEW BUSINESS

CONSIDERATION OF ADOPTION OF DRAFT CITY OF FARMINGTON HILLS 2024 MASTER PLAN FOR FUTURE LAND USE.

Director of Planning & Community Development Kettler-Schmult introduced the 2024 Master Plan for Future Land Use. The Master Plan is the culmination of 2 years of effort by the Planning Commission, City Planner Perdonik, the City's consultant team from Giffels Webster, and others in the City. The Master Plan represents the vision for the future of Farmington Hills.

Planning Consultant Bahm, Giffels Webster, presented the 2024 Master Plan, which had been adopted by the Planning Commission at their July 25, 2024 meeting.

Referencing the building blocks in the plan, Planning Consultant Bahm reviewed the work that had been done since the planning process had its kick-off in March 2022. The process had been very thorough, and the Planning Commission is ready to move on to the next steps, which will implement the plan.

The building blocks are:

- Housing
- Transportation
- Places that matter
- Quality redevelopment
- Economic development
- Innovation
- Sustainability & Resiliency
- Community Wellness
- Diversity

Planning Consultant Bahm pointed out that the Master Plan sets up policy for future land use decisions but does not change the Zoning Ordinance. The Planning Commission is ready to move forward with the implementation process by working through the Ordinance to recommend zoning changes, so that the Zoning Ordinance and the Master Plan are aligned.

Council discussion

Councilmember Aldred congratulated the Planning Commission on the excellent Master Plan document, which includes 59 objectives that need to be prioritized. He looked forward to the prioritization of Zoning Ordinance changes as part of the work now needed to implement the Plan.

- In response, Planning Consultant Bahm said one of the first implementation steps will include holding a joint meeting with City Council and Planning Commission, in order to come to consensus regarding priorities for implementation.

Mayor Pro Tem Bridges spoke to the need to market the plan throughout the Farmington Hills community.

- In response, Director Kettler-Schmult said press releases will be going out regarding the Master Plan, and future marketing efforts will be coordinated through Economic Development.
- City Manager Mekjian said that Corridor studies had gone out to bid, and the contracts would be awarded soon to study the Grand River Corridor, Orchard Lake Road Corridor, and 12 Mile Road Corridor. The work in the Corridors will heavily reference the Master Plan.

Mayor Rich thanked all who worked on this very comprehensive Master Plan.

The following preamble and resolution were offered by Councilperson Bruce and supported by Councilperson Bridges:

WHEREAS, the City Farmington Hills (the "City") City Council ("Council") created the City's Planning Commission (the "Commission") for the purposes provided in the Michigan Planning Enabling Act, Act 33

of 2008, as amended (the "Act"); and

WHEREAS, the Commission is empowered by the Act to make and approve a master plan as a guide for development within the City, and to amend such plan as necessary from time to time; and

WHEREAS, the City retained a professional planning consultant to assist the Commission with the technical studies necessary to amend the City's Master Plan; and

WHEREAS, pursuant to the Act, on May 17, 2022, the Commission transmitted a notice to each relevant entity provided in the Act explaining that it intends to prepare a master plan and requesting the recipient's cooperation and comment; and

WHEREAS, pursuant to the Act, at its April 18, 2024, special meeting, the Commission unanimously passed a motion to submit the draft City of Farmington Hills 2024 Master Plan for Future Land Use (the "draft Master Plan") to Council for review and comment; and

WHEREAS, pursuant to the Act, at its May 13, 2024, regular meeting, Council unanimously approved the distribution of the draft Master Plan; and

WHEREAS, pursuant to the Act, on May 16, 2024, the secretary of the Commission submitted a copy of the draft Master Plan for review and comment to each relevant entity provided in the Act, which sixty-three (63)-day review and comment period ended on July 18, 2024; and

WHEREAS, pursuant to the Act, the Commission held a public hearing on the draft Master Plan on July 25, 2024, at their regular meeting at City Hall; and

WHEREAS, the Commission found that the draft Master Plan is necessary for the continued development and appropriate redevelopment of the physical areas of the City; and

WHEREAS, the Commission approved the draft Master Plan, dated July 25, 2024, along with the text, maps, charts, graphs, and other descriptive materials contained in the Plan, including the Future Land Use Map, on July 25, 2024, at their regular meeting at City Hall; and

WHEREAS, Council found that the draft Master Plan is necessary for the continued development and appropriate redevelopment of the physical areas of the City;

NOW, THEREFORE, BE IT RESOLVED that the Council hereby approves the draft Master Plan, dated July 25, 2024, along with the text, maps, charts, graphs, and other descriptive materials contained in the Plan, including the Future Land Use Map.

BE IT FURTHER ORDERED that an attested copy of the approved Master Plan shall be certified to all entities as required by the Act.

Michelle Austin gave an update regarding Oakland County Foster Closet, a 501(c)(3) non-profit. The Foster Closet had served 12,700 children and given out 310,000 items since it was created 11 years ago and had partnered with several other local organizations to help children in need.
