In the month of May, the Emergency Preparedness Commission reminds everyone to think summer, but be prepared for summer-related situations.

Summer in Farmington Hills is long anticipated and never seems to last long enough, so it is easy to forget that hyperthermia (high body temperature) can be life threatening and other heat emergencies can cause trauma and suffering. Yet heat illnesses are easily preventable by taking necessary precautions in hot weather.

Common causes of heat emergencies include high temperature and humidity, dehydration, prolonged or excessive exercise, excess clothing, alcohol use, and certain medications.

Heat emergencies can be prevented by wearing loose-fitting, lightweight clothing, resting frequently and seeking shade when possible, avoiding hot places, drinking adequate fluids, exercising gradually and increasing water intake.

\*\* Remember: Never leave a child (or a pet) unattended in a vehicle.

# CONSIDERATION OF AUTHORIZING THE CITY MANAGER TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITIES OF FARMINGTON HILLS AND FARMINGTON AND THE FARMINGTON PUBLIC SCHOOLS FOR THE PURPOSE OF PARTICIPATING IN THE GEORGETOWN UNIVERSITY ENERGY PRIZE CMR 5-14-48 Assistant to the City Manager Geinzer introduced the Chairperson of the Commission on Energy and Environmental Sustainability, Mark VanEtten, Vice-Chairperson Leon Zolkower, and the Mayor's Millennial Congress representative Adam DiVita. Mr. Geinzer stated that they are requesting the City Council to consider authorizing staff to sign a Memorandum of Understanding for the purpose of

participating in the Georgetown University Energy Prize (GUEP). Mr. Geinzer explained that the competition creates a unique opportunity for the community and written commitment has been received from Consumer's Energy for their participation; and they are still waiting for Detroit Edison.

The Competition will:

- Challenge a large number of communities to work together with their local governments and utilities to create and begin implementing long-term plans for the continual improvement of energy efficiency;
- Stimulate replicable innovations in community energy efficiency;
- Encourage a large number of communities to participate in the early stages of the competition;
- Educate the public and engage students in energy efficiency issues, methods, and benefits, and encourage lasting behavior change;
- Help to grow markets for products and services that facilitate energy efficiency and renewable, clean energy production; and
- Reward the community as a whole, and not specific individuals.

Mr. Geinzer noted that the winner of the Competition will receive a projected \$5 million prize purse, to be spent on energy-efficiency programs that reward the community as a whole. There may also be additional prizes for top performing communities.

He further explained that the Memorandum of Understanding outlines the cooperation between the City of Farmington Hills, City of Farmington and Farmington Public Schools, with Farmington Hills serving as the project lead. A funding commitment from both Cities is written into the Memorandum of Understanding to help support program.

Mr. VanEtten stated that the commission is looking forward to working on this project for the next three years. He commented that this will give the opportunity to stage Farmington Hills on a national level and provide technical assistance, workshops and possible opportunities for grants and other funding.
