EMERGENCY PREPAREDNESS COMMISSION TIP OF THE MONTH

In August the Emergency Preparedness Commission is reminding all families with school age children to make sure they update their children's emergency contact information on file with their schools, and to review emergency procedures with their families, should an event happen while their children are at school, or on their way to and from school.

Our children are exposed to a lot of alarming and sometimes alarming information on a daily basis, especially from television. Your words and actions can provide reassurance while also easing their fears. It is important to engage your child and discuss what they see and hear. When you do, be sure to present a realistic picture that is both honest and manageable. Children are not helpless, especially when given tools to help manage their own environment.

PUBLIC QUESTIONS AND COMMENTS

Marianne Weiss, Crompton Circle, acknowledged a letter from her and her husband dated August 6, 2018 that was addressed to City Council regarding the proposed Charter amendment and method for transitioning from a special assessment to a road millage. She expressed concern that the proposed change would refund monies to current owners of property that are within an active special assessment rather than a previous owner who may have actually paid the assessment and has since moved as they have.

Khaya Davidson, Glencreek, read an email she sent to Mayor Massey and City Manager Boyer regarding Mayors for Peace and requesting the City to join the organization and become involved in the movement to prevent nuclear war.

Ted Gruller, Old Homestead, acknowledged the difficult decision Council made in trying to address the road issues but expressed the same concern with regard to the proposed method of refunding the money. He stated that if there is something that could be done to refund the money to those who have paid it, the residents who are in the process of selling their homes or have sold would appreciate it.

COUNCIL MEMBERS COMMENTS AND ANNOUNCEMENTS

The following comments and/or announcements were made by Council:

- Councilmember Rich noted that the city's financial advisors made a recommendation that will save the city approximatley\$50,000 per year in investment fees.
- Councilmember Bridges mentioned that Central Services will be hosting a vendor outreach program in early 2019 to educate businesses on how to do business with Farmington Hills and provide an opportunity to register with the consortium as a vendor.
- Mayor Massey thanked all of the participants of the softball fundraising event held for Suicide Awareness and Prevention and thanked the Fredericks family who lost their son and came out to support the event. Next year's softball tournament is scheduled for August 10, 2019
- Mayor Massey mentioned a public meeting held at the Library on building a culture of trust hosted initiated by Mabel Fox that included some good presentations and discussion.

CITY MANAGER UPDATE

City Manager Boyer mentioned the following:

- Thanked voters for passing the Parks and Recreation millage renewal
- Mentioned an open house event at the ice arena on August 20th with free skating, free rentals and free lessons from 5:30pm-7pm.
- In response to the comments made regarding the proposed Charter Amendment, the City is currently working a letter that will go out to all residents in an active Special Assessment Districts and how the refunds would be handled.

City Attorney Joppich stated that the City just recently received notice of approval required for this Charter Amendment to appear on the November ballot. He explained how the refunds would be handled per the approved Charter amendment ballot language and if approved by the voters.

UNFINISHED BUSINESS

CONSIDERATION OF APPROVAL OF THE ENACTMENT OF ORDINANCE C-5-2018 TO AMEND THE FARMINGTON HILLS CITY CODE BY AMENDING CHAPTER 2, "ADMINISTRATION," ARTICLE IV, "BOARDS, COMMISSIONS AND COUNCILS," DIVISION 8, "FARMINGTON AREA ARTS COMMISSION," SECTION 2-222, "PURPOSE" TO UPDATE THE PURPOSE OF THE COMMISSION, AND DIVISION 9, "COMMISSION TO INCREASE VOTER PARTICIPATION" TO CORRECT THE COMMISSION NAME; AND APPROVAL OF SUMMARY FOR PUBLICATION.

Attorney Joppich stated that this ordinance was introduced at the last meeting to update the purpose of the Farmington Area Arts Commission and correct the name of the Committee to Increase Voter Participation. He noted that the suggested change at the time of introduction was made and is coming to Council for enactment.

MOTION by Bruce, support by Lerner, that the City Council of Farmington Hills hereby approves ENACTMENT of Ordinance C-5-2018 to amend the Farmington Hills City Code by amending Chapter 2, "Administration," Article IV, "Boards, Commissions and Councils," Division 8, "Farmington Area Arts Commission," Section 2-222, "Purpose" to update the purpose of the Commission, and Division 9, "Commission on Voter Participation" to correct the Commission name; and approval of summary for publication.

NEW BUSINESS

CONSIDERATION OF A FREEDOM OF INFORMATION ACT (FOIA) APPEAL.

Attorney Joppich explained that the Freedom of Information request was received by the City and denied per the Act as the records were exempt from disclosure. The requestor is appealing that denial of records and the process is for the appeal to come before City Council for consideration. Attorney Joppich acknowledged that Ms. Davis was not present at the meeting this evening. He explained that the details for the denial were outlined in his attorney-client privileged memo provided to City Council and was

based on the fact that release of the records was prohibited by State Statute and if released could be a misdemeanor under that Statue.

Other options for Ms. Davis were discussed and she was encouraged to pursue some of these other options if she was watching this evening.

MOTION by Bruce, support by Bridges, that the City Council of Farmington Hills hereby denies the Freedom of Information Act appeal from Tara Davis based on the fact that state statute MCL 28.247 and Crime Victim Rights Act specifically prohibits release of this confidential information.

Attorney Joppich stated that Ms. Davis also has the right under the Act to appeal this matter to Circuit Court.

City Clerk Smith indicated that Ms. Davis was notified that this matter was before City Council this evening and would follow up with her on the actions taken this evening.

CONSIDERATION OF APPROVAL OF A PURCHASE AGREEMENT FOR 30790 EIGHT MILE ROAD. CMR 8-18-62

Gary Mekjian explained that the city received the property in question due to a tax foreclosure and the property is zoned Light Industrial and has sat vacant for approximately 11 years. Back in 2011 the Brownfield Redevelopment Authority toured the site and recommended an environmental study of the building and property and a Phase1 and Phase 2 environmental study and Due Care Plan for the site were completed in 2012 and in 2013 the building was demolished and the site remediated in compliance with these plans.

The City had the property appraised by an outside, independent commercial real estate appraiser and the City has been approached by an adjacent property/business owner to purchase the property for the full appraised value.

The City Attorney and the purchaser's attorney have successfully negotiated a purchase agreement that is before Council this evening for consideration.

MOTION by Knol, support by Lerner, that the City Council of Farmington Hills hereby authorizes the City Manager to sign a purchase agreement on behalf of the City to sell 30790 Eight Mile Road to D'An-Co Properties, L.L.C. in the amount of \$180,000.

CONSIDERATION OF APPROVAL OF OPERATION AND MAINTENANCE AGREEMENTS FOR WATER AND SANITARY SEWER WITH OAKLAND COUNTY. CMR 8-18-63

Director of Public Services Mondora explained that Oakland County Water Resources Commissioner's Office has provided public water and sanitary sewer operation and maintenance services for the City for several decades and the term of that contract is expired. She reviewed the complex city systems and some of the services provided by the County and noted that the term of the proposed agreement to continue these services is for ten years with an option to extend for another 10 years and a termination clause with 180 days' notice.

MOTION by Bridges, support by Bruce, that the City Council of Farmington Hills hereby authorizes the City Manager and City Clerk to sign the City of Farmington Hills Sewer System Operation and Maintenance Agreement and the City of Farmington Hills Water System Operation and Maintenance Agreement.

- Minimum means of egress widths must comply with Table 3303.12.2 (IFC 2015)
- Tents require NFPA 701 flame resistance label affixed to panels/canopy
- Proponent must contact Fire Prevention prior to event to schedule a site inspection
- Event shall comply with the minimum Fire Prevention Code Requirements
