## **VULNERABLE CITIZENS PROGRAM:**

- Asst. Police Chief, Jeff King presented a new program where citizens can report to the Farmington Hills police information related to vulnerable citizens in our community, in an effort to assist responders in emergency situations.
- The system "Premise", can house information related to disabilities, dementia, autism, PPOs, etc., providing responders additional information beyond what might be available in the CAD system or articulated by the reporter.
- Citizens interested in making a report should call the Farmington Hills police non-emergency line.
- Asst. Chief King asked the committee to look for opportunities to share this information with our citizens through our interactions with the community as a part of our role with the Health Commission.
