PUBLIC HEARING

PUBLIC HEARING AND CONSIDERATION OF THE SERVICE AGREEMENT WITH C.A.R.E.S. OF FARMINGTON HILLS AND PUBLIC DISCLOSURE OF THE VOLUNTEER RELATIONSHIP BETWEEN COUNCIL MEMBER MASSEY AND C.A.R.E.S. OF FARMINGTON HILLS. CMR 1-21-01

Charmaine Kettler-Schmult, Community Development Coordinator explained that City Council recognized the need for additional food service to eligible residents of Farmington Hills and in April 2020 a request for funding was presented by C.A.R.E.S. of Farmington Hills and at that meeting Councilmember Massey disclosed his relationship with C.A.R.E.S. and did not participate in the discussion or approval of regular CDBG funds.

In June, City Council approved additional funding for food banks and food distribution and the approvals went through reviews of the Detroit Housing and Urban Development Field Office (HUD) and Federal Office of General Counsel who reviewed the actions of City Council and supporting documentation and determined that a public disclosure of this relationship was necessary in order to finalize the waiver and accept the request for HUD funding.

Ms. Kettler-Schmult stated that Councilmember Massey has disclosed in a sworn statement that he has a volunteer relationship with C.A.R.E.S. of Farmington Hills and is one of the incorporators of that organization and continues to act as Director and Officer of the non-profit

and he nor anyone in his family has any interest in any company that does busines with C.A.R.E.S. of Farmington Hills nor does he or anyone in his family receive any compensation from C.A.R.E.S. of Farmington Hills.

She noted that per the Federal regulations according to the regulations conflicts prohibited 24 CFR570.611(b) the relationship is required to be disclosed and statement made as part of the minutes:

This general rule indicates that no persons described in Paragraph C of this section who exercise or have exercised any function or responsibility with respect to CDBG activities assisted under this part or who are in a position to participate in decision-making process or gain inside information with regard to such activities may obtain a financial interest or benefit from a CDBG assisted activity or have any financial interest in any contract, subcontract or agreement with respect to a CDBG assisted activity or with respect to proceeds of the CDBG activity either for themselves or those whom they have business or immediate family ties during their tenure or for one year thereafter.

In this case, Councilmember Massey is in a position to participate in decision-making process with respect to CDBG activities and in a position to gain inside information with regard to CDBG activities, including which organizations receive CDBG funds. As Councilmember Massey is part of that organization to request and possibly receive CDBG funds, Councilmember Massey did not participate in the council's decision making to allocate CDBG funds to C.A.R.E.S. and has recused himself from discussion and abstained from voting on the issue at the April 13, 2020 Council meeting.

According to federal regulations, any individual in this position cannot obtain a financial benefit from CDBG funds. Councilmember Massey nor his family received any financial interest in the proceeds of any CDBG assisted activity.

Therefore, the City Attorney for the City of Farmington Hills has reviewed the matter for potential conflicts with the state and local conflict of interest policies and has determined, in his opinion, that this matter would not violate state or local laws and there should be no conflict in the federal regulations.

City Attorney Joppich commented that the above statements made by Ms. Kettler-Schmult are required by HUD to be read into the record to be included in the minutes and should be referenced during the next item regarding CDBG funding as well.

Mayor Barnett opened the public hearing. There being no comments, the public hearing was closed by Mayor Barnett.

PUBLIC HEARING AND CONSIDERATION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM YEAR 2019 ANNUAL ACTION PLAN AMENDMENT (CDBG-CV3 FUNDING). CMR 1-21-02

Charmaine Kettler-Schmult, Community Development Coordinator, explained that this Public Hearing is for an amendment to the 2019 Annual Action Plan specifically to address the second round of CDBG funding that is specifically for the preparation, preventing or responding to COVID. Allocation was authorized from the Federal Government through the Housing and Urban Development Department and the City has been allocated 334,118.00. HUD had been allowed with this allocation to have certain waivers and allowances and one of those allowances was for virtual meetings. All eligible CDBG activities have to meet one of three national objectives: benefit low and moderate-income families, aide in prevention of slum or blight or meet a need having a particular urgency.

She noted that City staff reached out to local non-profit organizations to inform them of the opportunity to apply for the funding and the City received applications from 3 organizations expressing the need for food banks and food distribution and/or mortgage/rental and utility assistance. Staff has developed a proposed budget for review by Council that will be submitted to HUD for approval that will include Program Administration in the amount of \$36,000; food bank/food distribution in the amount of \$103,118 and mortgage/rent and utility assistance in amount of \$119,000.

Attorney Joppich stated that since there are funds that would be going to C.A.R.E.S. of Farmington Hills from this funding as well, he reiterated that the same statements made at the previous hearing regarding the disclosure of the relationship of Councilmember Massey to C.A.R.E.S. of Farmington Hills would also apply to this matter and should be part of the minutes being Code of Federal Regulations Section 24 570.611(b) Conflicts Prohibited and the full disclosure. My legal opinion is the same as the previous public hearing as well.

Mayor Barnett opened the public hearing. There being no comments, the public hearing was closed by Mayor Barnett.

In response to City Council, Ms. Kettler-Schmult explained that the city will receive initial applications for those in need of funding and they will get the information to appropriate providers to be most efficient.

Police Chief King explained the program provided by Families Against Narcotics (FAN), which is a post-overdose wellness check program, and the role the Police Department would have in the program. He noted that the focus of the program is to save lives, assist substance abuse disorder (SUD) victims and their families in recovery, reduce the stigma associated with SUD, reduce repeat deployment of emergency resources and server the citizens of the community.

It was questioned if there was any consideration of having a social worker on site to meet with citizens rather than having the first contact being with the Police Department and Officers have the skills necessary to address the substance abuse or better to have a social worker on staff to make those types of initial contacts.

Police Chief King explained that the program starts with an overdose and so Police would be the initial contact and the response team would get involved after that initial contact. FAN created this program based on their interaction with people that suffer from this disorder and finding that their comfort level was highest with Police Officers. The program is in conjunction with the traditional law enforcement role of being first responders and then following up with further life-saving measures.
