3 loans for small business are available

1. Oakland Together Small Business Recovery Grant

These funds ``will help retail stores, restaurants and personal service businesses like beauty salons and fitness centers that were impacted by the Pandemic. Eligible businesses have suffered actual or anticipated losses from March 2020 through July 2020 including loss of revenue, operating at a reduced level of production sales employment or service or were fully closed for all operations and are now in the process of reopening qualify.

2. State of Michigan is offering the Michigan Small Business Restart Program to support business impacted by COVID. Businesses can apply for grants up to \$20,000. Applications are available now and are due by August 5.

3. Michigan Entrepreneur Resilience Fund Loans. this is intended for geographically and demographically under-represented and disadvantaged individuals.
