PUBLIC QUESTIONS AND COMMENTS

Lorna Slenkai, Greening Street, expressed concern regarding loud house parties being held on her street.

Fran Vallely, Greening Street, inquired about the substantial completion date for the Greening Street Road project and noted several outstanding items to be addressed. She also expressed concern over the loud house parties on Greening and suggested allowing for only parking on one side of the street to address the traffic being generated.

Jim Cubera, City Engineer, explained that sign-off on a road construction project typically occurs the spring following construction. He will look into the concerns raised this evening.

City Manager Boyer stated that he would address the issue of the loud parties with the Police Chief to determine what can be done.

COUNCIL MEMBERS COMMENTS AND ANNOUNCEMENTS

Councilmember Rich commented on the Save Our Adolescents from Prostitution (S.O.A.P) event joined by County Commissioner Janet Jackson that was held this past weekend to promote awareness of human trafficking. She mentioned an app that is available that allows for travelers to take pictures of hotel rooms and post those to the app to assist law enforcement in identifying hotels.

Councilmember Lerner recognized members of the audience who were instrumental in getting the city road millage passed.

Mayor Massey mentioned the Farmington SAFE Softball Tournament held this past weekend and congratulated the Fire Department for winning the tournament.

CITY MANAGER UPDATE

City Manager Boyer provided the following update:

NEW BUSINESS:

CONSIDERATION OF APPROVAL OF THE INTRODUCTION OF AN ORDINANCE TO AMEND THE FARMINGTON HILLS CODE OF ORDINANCES, CHAPTER 19, "PARKS AND RECREATION," ARTICLE III, "RULES AND REGULATIONS," SECTION 19-52, "BICYCLES," TO PROHIBIT BICYCLES AND SCOOTERS AT THE RILEY SKATE PARK. CMR 8-19-83

Director of Special Services Ellen Schnackel explained that the Riley Skate Park was designed for skateboards and in-line skating only and was not designed for mixed-use. She outlined issues with repeat offenders using bicycles and scooters at the park and the damage it was causing to the concrete. Currently city staff and police officers ask offenders to leave but have no authority to issue tickets to repeat offenders. She stated that the proposed ordinance was discussed on July 22, 2019 by City Council at their study session meeting and is being proposed this evening to City Council for consideration of approval.

Councilmember Rich stated that she would prefer to first review the penalty structure under Chapter 19 that would make a violation of the ordinance a misdemeanor before considering the ordinance amendment.

Discussion was held on the option to make a violation of this ordinance a civil infraction versus a misdemeanor. It was pointed out that any violation of Chapter 19 is currently a misdemeanor and that that the proposed amendment is to only add a sentence to the existing ordinance to prohibit bicycles and scooters at the park.

MOTION by Lerner, support by Knol to approve the Introduction of an Ordinance to amend the Farmington Hills Code of Ordinances, Chapter 19, "Parks and Recreation," Article III, Rules and Regulations," Section 19-52, "Bicycles," to prohibit bicycles and scooters at the Riley Skate Park.

Councilmember Bruce stated that he would not support the motion as he would prefer that the penalty was a civil infraction.

Councilmember Rich concurred with Dr. Bruce and preferred taking a measured approach with regard to reviewing the penalties. She added that there is currently no signage prohibiting scooters at the park, only bicycles.

Other members of Council indicated that this was a tool for law enforcement to use for repeat offenders and that there was a need to address the current situation at the park and that penalties for violations under Chapter 19 could be reviewed as a separate issue at a later time.

Director of Public Services Karen Mondora discussed the need for the water main replacement and noted that the project came in below engineering's estimate. The project is being funded through the water fund and there is no payback agreement associated with the project.

WHEREAS, The Michigan Legislature created a requirement (MCL 247.663) as part of the Transportation Funding Package of 2015 that requires each city and village to adopt a Local Agency Pavement Warranty Program that was approved by the Michigan Department of Transportation in 2018;

WHEREAS, the City of Farmington Hills adopted the Michigan Local Agency Pavement Warranty Program on August 12, 2019.

WHEREAS, the City of Farmington Hills agrees to consider a local pavement warranty on each project that includes \$2 million or more in paving-related items *and* includes any state or federal funds;

WHEREAS, the Local Agency Pavement Warranty Program law requires each city and village to report annually on each project that includes \$2 million or more in paving-related items *and* includes any state or federal funds, whether or not a warranty was utilized in the project;

WHEREAS, City of Farmington Hills agrees to implement the Michigan Local Agency Pavement Warranty Program consistent with the Guidelines for Local Agency Pavement Warranty Program document that was approved by the Michigan Department of Transportation in 2018; and which the City of Farmington Hills adopted Implementation Policy defines the City of Farmington Hills intent of its pavement warranty program;

NOW THEREFORE BE IT RESOLVED, the City of Farmington Hills hereby agrees to implement the Local Agency Pavement Warranty Program and annually report in accordance with the law.
