Interior-

1. a. Baxtresser reported that he had a been in touch with Bryan Farmer of The Special Services Department concerning the quotes received for the Design services at the Heritage and History Center. Mr. Farmer said that they received three proposals and they were all higher than expected, ranging at the low end at \$ 13,800.00 to a high of \$ 73,200.00. He also mentioned that Special Services would be doing an in-depth review of the proposals and that would happen the following week. Baxtresser said that when he received that information, he would share it with the commissioners via email so a procedural plan could be formulated. If timing became a factor because of the fiscal year, a special Commission meeting might need to be set up.

- **D.** Historical Markers-
 - 1. Stuart Little: Baxtresser told the Commission that he had gone to Heritage Park to install the Brigid Stolberg plaque and was told that although the bench location of the plaque had been selected, permission for the installation had not actually been granted. Baxtresser said he would do follow-up.
 - 2. Pasadena Park- On hold.
 - 3. Palmer Sherman House- Awaiting further research information, with possible assistance from Rochelle Danquah who had attended a previous meeting.
 - 4. The Pernambuco Hollow- Sign has yet to be reinstalled using new poles. Cox will inquire again as to status.
 - 5. Boys Republic-Baxtresser shared a possible letter to be sent to Wellspring Lutheran Community Services explaining the installation of a historic marker at that site. Willyard thought that letter should be sent after the Commission approved the final text for the proposed marker. Baxtresser will email that text to the commissioners and that process can move forward at the next meeting.
