### PRESENTATION AND ACCEPTANCE OF THE CITY'S FY 2017/18 AUDITED COMPREHENSIVE ANNUAL FINANCIAL REPORT

Steve Barr, Director of Finance, provided Council with the following highlights from the FY 17/18 Audited Comprehensive Annual Financial Report:

- The City was awarded the Certificate of Achievement for Excellence in Financial Reporting from the Government Finance Officers Association (GFOA) for the 20<sup>th</sup> year
- The City received the GFOA Distinguished Budget Award for the 35 year in a row and since the awards inception, which is quite a point of pride for the city
- Excellent bond ratings were received AAA (highest bond rating) from Standards and Poor and Aa1 (second highest bond rating) from Moody
- An unmodified opinion (highest possible) was received by Plante & Moran
- The General fund is financially sound with the unassigned fund balance at 25%
- The City's pension system is 79% funded and retiree healthcare is 108% funded

Director Barr thanked his staff for all of their hard work, specifically Shu-Fen Lin, City Comptroller.

Doug Bohrer, Plante & Moran, summarized the city's audit results, noting the following:

- The City has received an unmodified opinion on financial statements which is the highest opinion that can be received and means the statements are materially correct both in numbers as well as disclosures.
- There were no internal control weaknesses, material weaknesses or significant deficiencies identified.
- A new fund, the Community Center Renovation Fund, was established to handle the purchase of the new high school and middle school properties.

Tom Kempa, Plante and Moran, reviewed the budget graphs with Council and Tim St. Andrews, Plante and Moran, discussed the city's legacy costs for retiree health care and health care and pension contributions and capital investments.
