Absent Voter turnout:

25.659 AV ballots were issued

24,641 AV ballots returned (96%)

16,706 Precinct ballots were cast

Overall unofficial turnout was 73%

Both the Farmington Hills ballot proposals passed as well as the FPS, Library, and Oakland County Parks and Rec millages.

c. Review Strategic Plan

The discussion focused on getting more involved with the schools. Perhaps a mock election or candidate forum could be held at the high school before the mid-term elections. We should continue liaison with students, which has been productive.
