- 6. Unfinished Business
 - Statewide Drinking Water Advisory Council (SDWAC) Survey Results
 - Katie provided information related to the SDWAC survey findings. EGLE is hosting two webinars to review the findings on 4/20/23 at 10 a.m. and 4/26/23 at 9 a.m.
 - Katie will forward the webinar invitations to the WSAC members once received.
 - WRC has revised the standard operating procedure for Lead and Copper sampling to include notification *by phone* (in addition to notification by mail) to all residents with lead results above not detected. Educational information will be provided to any residents with lead results above not detected. All residents who participate in the lead and copper sampling program will continue to be mailed their results along with pertinent health information and instructions for maintaining quality drinking water in their homes.
- 7. New Business
 - SDWAC Update
 - In 2025, the lead action level will be lowered from 15ppb to 12ppb.
 - All water systems must provide the state with an inventory of service line materials by January 1, 2025. Farmington Hills has no known lead service lines. A physical survey will be done at a listing of randomly chosen addresses to physically view pipe materials in 3 locations (public side of stop box, private side of stop box, piping inside the home).
 - EGLE formula to determine the number of surveys to be performed in each community:

- EGLE is in the process of creating a new webpage to provide drinking water information for residents and water systems at www.Michigan.gov/knowyourwater.
- Farmington Hills Public Education and Awareness
 - The following additional methods to provide water quality information to residents were discussed:
 - 1. Posting videos and articles on the City's website.
 - 2. Creating hands-on displays for the booth at the annual City Open House. Katie brought a display with different pipe materials and handouts. The handouts show older model faucets with removable aerators. The group decided that it may be a good idea to understand where current model faucet aerators are located. Mike Pucher will research and discuss with the plumbers in his department.
 - Introduce service line identification in elementary schools or summer programs. It was suggested that the place to start would be to develop a decision tree to show students how to identify the service line material.
 - 4. Action item: Tammy and Katie will seek out information to share that may be available from AWWA, EGLE, or GLWA.
- Election of Officers
 - The WSAC Bylaws identifies the election of Chair, Vice-Chair and Secretary to serve a

one-year term. Each year, the officers shall be chosen by a vote of the WSAC members within 30-days of the Farmington Hills City Council appointments for Commissions and Councils. Officers cannot serve more than two successive years in one position. WSAC members are appointed or re-appointed by Farmington Hills City Council for a term of 3 years.

- The reappointment terms are staggered:
 - 1. Katie Kennedy term expires on 2/1/2026.
 - 2. Tammy Gushard and Mike Pucher terms expire on 2/1/2025.
 - 3. Tony Drautz and Erin Quetell terms expire on 2/1/2024.
