Detailed Description of Work

<p>EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.</p>

Instructions for Completing Application

<p>Mechanical work shall not be started until an application for permit has been filled with and issued by Farmington Hills Building Department. All installation shall be in conformance with the Michigan Mechanical Code. No work shall be concealed until it has been inspected. When ready for inspection, go online to bdinspectrequest@fhgov.com or call 248-871-2450. You will need your permit number and job location. Your request will be scheduled for the next availability.</p>
