WHEREAS, Dr. Randy Bruce served on the National League of Cities Human Development Committee, helping to develop policy positions on health and social service initiatives, and served as a member of the 47th District Court Sobriety Court Advisory Committee, guiding individuals with substance abuse issues through their court-ordered recovery programs; and

WHEREAS, Dr. Bruce's vision, calm guidance, open-mindedness, and commitment to the people of this community has had a strong and lasting impact on the quality of life in the City of Farmington Hills.

NOW, THEREFORE, BE IT RESOLVED that I, Ken Massey, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby recognize and honor **Dr. Randy Bruce** for his vital contributions to the community and thank him for his dedication to the City of Farmington Hills as he retires from City Council to pursue future endeavors.

PUBLIC HEARING

PUBLIC HEARING AND CONSIDERATION OF ADOPTION OF A RESOLUTION APPROVING THE BROWNFIELD PLAN FOR 29995 TWELVE MILE ROAD. CMR10-19-101

Samantha Seimer, Economic Development Director, explained that the plan before City Council this evening is for property located at 29995 12 Mile Road and the purpose of the Brownfield Redevelopment Financing Act, PA 381, is to promote reinvestment and revitalize properties that are functionally obsolete throughout the community. The property in question meets this criteria and the plan authorizes the use of previously captured Brownfield dollars to be used for pre-development activities, demolition and lead and asbestos abatement. There is no taxable value to the property so there is no impact to external taxing jurisdictions nor will any tax increment revenue be captured.

WHEREAS, the Brownfield Redevelopment Authority (the "Authority") of the City of Farmington Hills (the "City"), pursuant to and in accordance with the provisions of the Brownfield Redevelopment Financing, Act, being Act 381 of the Public Acts of the State of Michigan of 1996, as amended (the "Act"), has prepared and recommended for approval by the City Council of the City (the "Council"), a Brownfield Plan (the "Plan") pursuant to and in accordance with Section 13 of the Act; and

WHEREAS, the City Council held a public hearing on proposed Brownfield Redevelopment Plan for (the "Plan") for the property located at 29995 Twelve Mile Road, Farmington Hills, MI 48334 (the "Property") following the publication of notice in the manner required by Section 13(10) of the Act; and

WHEREAS, the City has, at least ten (10) days before the public hearing, provided notice of the public hearing to the taxing jurisdictions affected by the Plan which levy taxes subject to capture under the Act (the "Taxing Jurisdictions") and have informed such Taxing Jurisdictions about the fiscal and economic implications of the proposed Plan, and the Council has provided the Taxing Jurisdictions the right to be heard at the public hearing in accordance with Section 13(13) of the Act; and

WHEREAS, the Council has made the following determinations and findings:

- A. The Plan constitutes a public purpose under the Act;
- B. The Plan meets all of the requirements for a brownfield plan set forth in Section 13 of the Act;
- C. The proposed method of financing the costs of the eligible activities, as described in the Plan, is feasible and the Authority has the ability to arrange the financing;
- D. The costs of the eligible activities proposed in the Plan are reasonable and necessary to carry out the purposes of the Act;
- E. The amount of captured taxable value estimated to result from the adoption of the Plan is reasonable; and

WHEREAS, as a result of its review of the Plan and upon consideration of the views and recommendations of the Taxing Jurisdictions, the Council desires to proceed with approval of the Plan.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Plan Approved. Pursuant to the authority vested in the Council by the Act, and pursuant to and in accordance with the provisions of Section 14 of the Act, the Plan is hereby approved in the form attached as Exhibit A to this Resolution.

2. Severability. Should any section, clause or phrase of this Resolution be declared by the Courts to be invalid, the same shall not affect the validity of this Resolution as a whole nor any part thereof other than the part so declared to be invalid.

3. Repeals. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.
