UNFINISHED BUSINESS

RECONSIDERATION OF A RESOLUTION ESTABLISHING THE 13 MILE ROAD SANITARY SEWER PAYBACK DISTRICT (DRAKE ROAD TO MARVIN ROAD) AND THE FINAL PAYBACK COSTS.

City Manager Boyer explained that this resolution establishing a sanitary sewer payback district for 13 Mile Road was approved by City Council last week and after discussing the resolution with staff further, he suggested extending the time period in which residents could connect to five (5) years rather than just one (1) year and still spread their payments over a period of 10 years. The revised resolution is before City Council this evening for reconsideration.

At a regular meeting of the City Council of the City of Farmington Hills, Oakland County, Michigan, held in the Council Chambers at City Hall on the 25th day of November, 2019, at 7:30 p.m., Eastern Standard Time.

The following resolution was offered by Councilmember Knol and supported by Councilmember Bridges:

13 MILE ROAD SANITARY SEWER PAYBACK DISTRICT (DRAKE TO MARVIN) SECTION 9

- WHEREAS the City Code Section 33-201 authorizes the City to establish connection charges for benefited properties to contribute to the cost of sanitary sewer construction, and
- WHEREAS a sanitary sewer and a service lead was installed by the City of Farmington Hills to provide sanitary sewer service to the properties listed below, and
- WHEREAS if a property is subdivided or split into more units than defined below, as outlined in City Code Section 27, each resulting connection would be responsible for one estimated unit of cost, as directed by the City Assessor, prior to the approval of the subdivision or split, and
- WHEREAS if a property opts to pay for its proportionate share of the improvement costs within five (5) calendar years of the approval of this resolution and that property is not being subdivided or split, that property shall have the option of amortizing the payback cost over ten years, with interest, through the City. The interest rate to be charged will be based on the rate of 10-year Treasury Bonds plus 1%, following the approval of the payback district. Any property who opts to finance the payback over ten years through the City will be required to sign a payback agreement, which will be prepared by the City Attorney, and
- WHEREAS the properties benefited by the construction of the sanitary sewer are as follows:

NOW, THEREFORE, BE IT RESOLVED that pursuant to Section 33-201 of the City Code, no connection, subdivision of land or lot split shall be permitted to the above-described properties until such time as the payback amount established above for each given property has been collected from the benefited property owners, such sum being the proportionate share of the construction of the sanitary sewer in addition to all other costs, charges, fees or other payment required by any code, ordinance or resolution of the City. The payback amount shall be collected in order to reimburse the City of Farmington Hills Sewer Reserve Fund for costs incurred for the construction of the improvement.

NEW BUSINESS

CONSIDERATION OF AN APPEAL OF A FREEDOM OF INFORMATION ACT (FOIA) REQUEST DATED OCTOBER 4, 2019

Attorney Carlito Young explained the FOIA appeal process and stated that upon review of Mr. Opperthauser's appeal and the documents provided with redactions or not provided as they did not exist, it is his opinion that the decision of the FOIA Coordinator in the Farmington Hills Police Department should be upheld. The information redacted from the documents was exempt from disclosure as it was of a personal nature or part of LIEN information and other information that was denied did not exist. He also noted that the federal FOIA law noted in Mr. Opperthauser's appeal did not apply in this instance and his decision is based on the state statute.

Mr. Opperthauser stated that the Freedom of Information Act, as he understood it, allowed for the redaction of certain words but not full sentences and he did not feel that all of the information redacted would have fallen under the exemptions in the act and that his request should be reconsidered.

Attorney Young clarified that the most significant portion of information redacted related to LIEN information, which is more protected under the law. The personal information redacted was limited to a few words.

MOTION by Massey, support by Bridges, , that the City Council of Farmington Hills hereby affirms the Police Department's redaction and denial of the contact information and LEIN information in this matter for the following reasons:

- 1. Both FOIA Section 43(1)(a) and legal precedent in Michigan support redacting an individuals' personal contact information, including that individual's personal phone number
- 2. The redacted LEIN information is non-public information and exempt from disclosure under FOIA Section 43(1)(d) and the LEIN statue
- 3. The federal FOIA law referenced in Mr. Opperthauser's appeal does not apply to the matter involving the City's Police Department

CONSIDERATION OF APPROVAL OF THE INTRODUCTION OF AN ORDINANCE AUTHORIZING THE CONVEYANCE OF PROPERTY LOCATED AT 30790 EIGHT MILE ROAD TO D'AN-CO PROPERTIES, LLC. CMR 12-19-119

Assistant City Manager Mekjian explained that the city attained the property through Oakland County due to tax foreclosure and it has sat vacant for several years. City staff worked with the Brownfield Redevelopment Authority and completed a phase 1 & phase 2 environmental study and due care plan and demolished the building and remediated the site. The property was appraised in 2018 and City Council authorized a purchase agreement to sell the property in the amount of \$180,000. Since that time staff has been working with the purchaser to finalize the closing of the sale and the warranty deed provided was drafted and reviewed by the City Attorney's Office. The City Charter requires the sale of property by ordinance and staff is recommending approval of the ordinance to convey the property.

MOTION by Massey, support by Newlin, that the City Council of Farmington Hills hereby approves the introduction of an ordinance authorizing the conveyance of the property located at 30790 Eight Mile Road, Farmington Hills, Michigan to D'An-Co, LLC as well as authorize the City Manager to sign the Warranty Deed, subject to minor changes based on title company comments and

final title policy exceptions, as reviewed and approved by the City Attorney, conveying the property the property to D'An-Co, LLC for the sum of \$180,000.
