PROCLAMATION RECOGNIZING SEPTEMBER 2019 AS OVARIAN CANCER AWARENESS MONTH

The following Proclamation was read by Councilmember Steckloff:

PROCLAMATION Ovarian Cancer Awareness Month September 2019

- WHEREAS, ovarian cancer is one of the most common cancers among women, and the American Cancer Society estimates that in the United States in 2019 about 22,530 new cases of ovarian cancer will be diagnosed and there will be about 13,980 deaths from the disease; and
- **WHEREAS**, ovarian cancer, which is rarely caught in the early stages, mainly develops in older women, with about half of the women diagnosed at age 63 or older; and
- WHEREAS, a woman's risk of getting ovarian cancer during her lifetime is about 1 in 78 and ovarian cancer ranks fifth in cancer deaths among women, accounting for more deaths than any other cancer of the female reproductive system; and
- WHEREAS, increased public awareness of the symptoms and risk factors of ovarian cancer, which include a family history of other types of genetically-related cancers, will enhance chances of early detection and increase survival rates; and

WHEREAS, more ovarian cancer research will help to develop better diagnostic tools and improved therapies, thereby offering women the opportunity to win their battle against this most deadly of all gynecologic cancers.

NOW, THEREFORE, BE IT RESOLVED that I, Ken Massey, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby proclaim September 2019 as **Ovarian Cancer Awareness Month** in the City of Farmington Hills and encourage every woman to become educated about the symptoms and risk factors of ovarian cancer.

PROCLAMATION RECOGNIZING SEPTEMBER 2019 AS SUICIDE PREVENTION AWARENESS MONTH

The following Proclamation was read by Councilmember Bruce and accepted by Fran Brown:

PROCLAMATION Suicide Prevention Awareness Month September 2019

- WHEREAS, more than 47,000 lives are lost annually to suicide, or approximately one every 13 minutes, and it is estimated that for every suicide, there are as many as 25 suicide attempts; and
- WHEREAS, depression and suicide span all demographics and all income levels, and 90% of those dying by suicide have a potentially treatable mental illness, if they can be connected with the right resources; and
- WHEREAS, suicide is the second leading cause of death among young people ages 15 to 34, and the tenth leading cause of all deaths in the U.S.; and
- **WHEREAS**, we can reduce these disturbing numbers through public awareness, education, and treatment, which are all crucial to preventing this tragic problem that causes loss of life and terrible suffering for the families and loved ones left behind; and
- WHEREAS, Farmington S.A.F.E. (Suicide Awareness For Everyone) is dedicated to making a difference by empowering community members, bringing the topics of depression and suicide out into the open for discussion, and connecting those who need assistance to the many resources available.

NOW, THEREFORE, BE IT RESOLVED that I, Ken Massey, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby proclaim September 2019 as **Suicide Prevention Awareness Month** in the City of Farmington Hills and encourage community members to "Talk About It" in order to raise awareness of depression and suicide and work together to prevent this tragic loss, which greatly impacts families and communities.

PROCLAMATION RECOGNIZING SEPTEMBER 2019 AS NATIONAL RECOVERY MONTH SUSTAINABLE FARMINGTON HILLS TIP OF THE MONTH

The following Proclamation was read by Councilmember Lerner and accepted by Firefighter Jim Etzin:

PROCLAMATION National Recovery Month September 2019

- WHEREAS, according to the Substance Abuse and Mental Health Services Administration, in 2017 an estimated 20.7 million people in the United States ages 12 or older needed substance use treatment; and
- **WHEREAS**, an estimated 2.1 million people had an opioid use disorder, which includes 1.7 million people with a prescription pain reliever disorder and 700,000 people with a heroin use disorder; and
- WHEREAS, the federal Centers for Disease Control reported that more than 72,000 Americans, a record number, died in 2017 from drug overdoses, and Michigan's drug overdose rates are higher than the national average with more deaths now from drug overdoses than from car crashes in our state; and
- WHEREAS, substance use disorders occur when the recurrent use of alcohol and/or drugs causes clinically or functionally significant impairment, such as health problems, disability, and failure to meet major responsibilities at work, school or home; and
- **WHEREAS**, stigma and stereotypes often keep people from seeking treatment that could improve their quality of life; and
- **WHEREAS**, substance use disorder recovery efforts benefit both individuals and their communities by focusing on the person's ability to live, work, learn, and fully contribute to society.

NOW, THEREFORE, BE IT RESOLVED that I, Ken Massey, Mayor of the City of Farmington Hills, on behalf of the City Council, do hereby proclaim September 2019 as **National Recovery Month** in the City of Farmington Hills and call upon our citizens, public and private institutions, businesses, and schools to increase their awareness and understanding of substance use and the need for appropriate and accessible services to promote recovery.

Gary Mekjian, Assistant City Manager, explained that the property was obtained by the City through tax reversion and since the City had no use for the property, staff contacted the adjacent property owner who expressed interest in purchasing the property. A signed purchase agreement was obtained and staff is recommending approval of the ordinance to convey the property to the adjacent property owner and authorization of the City Manager to sign the quit claim deed prepared by the City Attorney.

Director Ellen Schnackel stated that plans are underway for the repurposing of Harrison High School into the new Community Center. She introduced Andy Fountain, Senior Consultant for Plante Moran Cresa and Owner's Representative for the project.

Mr. Fountain explained that the Bid Package #1 for the community center project included 5 categories as well as fees associated with the construction manager services and contingencies for the project. This award is in the total amount of \$2,715,281 and the work is anticipated to commence October 1, 2019 and the project is slated to conclude in September, 2020.
