ADDED ITEM - CONNECTED VEHICLES

Mark Zachos presented information on connected vehicles and the potential to "re-brand" the City as the home of autonomous vehicles. He stated that the EDC did not need to invest in cars and technology, but just the idea that the City was friendly to the industry.

Motion by Zachos, support by Elliott to establish an EDC committee with a deadline of April 20188 to formulate a plan for moving forward.

CHAIRMAN'S REPORT

Mary Langhauser spoke about the Oakland County EDC and Business Finance Corporation. Most of the activity that the EDC is seeing today is refinancing and renewing of older bonds as they hit maturity. Many companies noted that the low cost of the bond financing is what allowed them to either the recent economic downturn. She noted that the Oakland County EDC was started in 1980 and with the exception of refinancing old bonds has not been active for some time.

Mary additionally spoke about the Oakland County Business Finance Corp. which was started in 1981. She stated that it is a Certified Development Corporation (CDC) and a SBA lending partner. She noted that the SBA 504 program is very popular.
