EMERGENCY PREPAREDNESS COMMISSION TIP OF THE MONTH JUNE 2018

In June the Farmington Hills Emergency Preparedness Commission is urging all our businesses to have an emergency preparedness plan in place for their individual workplaces.

An emergency is any unplanned event that can cause deaths or significant injuries to employees, customers, or the public; or that can shut down your business, disrupt operations, cause physical or environmental damage, or threaten the facility's financial standing or public image. There are some things and events that might be manageable for a large company, and yet constitute a true disaster for a small business.

Statistics show that more than 30 to 40 percent of small businesses that close in the wake of a natural disaster never reopen. They either lose their capital or their margins are so thin that they cannot survive the loss of cash flow while they repair.

Small and medium size business owners have often invested everything – all their time and resources – into making their business work. All the hard work that you put into growing your business could be meaningless without effective storm preparedness. Follow these simple steps to be ready: Complete a business impact analysis; create and practice an emergency response plan; create a crisis communications plan; protect your financial data; and **c**reate a business continuity plan.

The Emergency Preparedness Commission urges business owners to give appropriate attention to protecting their investment. A small investment of time will go a long way toward averting serious damage to your business, should an emergency event occur.

CONSIDERATION OF ADOPTION OF A RESOLUTION ESTABLISHING THE GREENCASTLE WATER MAIN PAYBACK DISTRICT AND THE FINAL PAYBACK COSTS. CMR 6-18-47

Tammy Gushard, Deputy Director of Public Services, reported that in March, 2017, City Council approved an Agreement with Oakland County for the construction of the Greencastle water main and establishment of a payback district, subject to the final costs being determined upon completion of the project. The City has since awarded the contract for the project and installation is now complete and the water main is in service and final costs have been determined. The total project cost is \$1,126,286.40, which is significantly less than the original estimate. Per the agreement with Oakland County, the County has agreed to pay 75% of the total project costs. The remaining 25% is to be paid for through the City's water reserve fund with reimbursement coming from the benefitting property owners per the proposed payback district. She noted that the cost per unit is \$4,772.40 and she outlined payment options for the benefitting property owners.

GREENCASTLE SUBDIVISION WATER MAIN PAYBACK DISTRICT

- WHEREAS the City Code Section 33-201 authorizes the City to establish connection charges for benefited properties to contribute to the cost of water main construction, and
- WHEREAS a water main was extended by City of Farmington Hills to provide water main services to the properties listed below, and
- WHEREAS if a property is subdivided or split into more units than defined below, as outlined in City Code Section 27, each resulting connection would be responsible for one estimated unit cost, as directed by the City Assessor, prior to the approval of the subdivision or split, and
- WHEREAS if a property opts to pay for its proportionate share of the improvement costs within two calendar years of the approval of this resolution and that property is not being subdivided or split, that property shall have the option of amortizing the payback cost over ten years, with interest, through the City. The interest rate to be charged will be based on the rate of 10-year Treasury Bonds plus 1%, following the approval of the payback district. Any property who opts to finance the payback over ten years through the City will be required to sign a payback agreement, which will be prepared by the City Attorney, and
- WHEREAS if a property does not connect to the water main within two calendar years of the approval of this resolution, that property must pay their proportionate share of cost in one lump sum.
