 - a. Dr. Massey also discussed the need for organizational management to have a historical record of past and next steps for the Innovation Center. The legal aspect must happen first.
 - b. Dr. Massey and Mr. Valentine discussed that more steps need to be taken to understand the process of operating under a 501c(3) at the Innovation Center.
 - c. Lew Cantor displayed a PowerPoint that can help market the Innovation Center.
- 2. School Milage Update
 - a. Jennifer Kamanski presented information to the board explaining Farmington Public School's taxpayer request for an increase of .6152. This will be on the November 8, 2022 ballot to be voted on.
